Race 1 - 2:25pm.**THE JOIN RACINGTV NOW EBF NOVICE STAKES (CLASS 4) (GBB RACE)**

Leaving the stalls, ROYAL ACCORD, placed fifth, jumped right-handed, into the path of CARRADOS (IRE), placed third, causing the rider of CARRADOS (IRE), to take a slight check, but after viewing a recording of the incident, it was found that no riding offence was involved.

The Clerk of the Scales reported that Rossa Ryan, the rider of SIMPLY BLUE, placed second, had been unable to weigh in, owing to being unseated after the line and the colt running loose. The Stewards were satisfied that the correct weight had been carried throughout the race and confirmed the placing of SIMPLY BLUE.

Following the race, James Doyle reported that CARRADOS (IRE), placed third, was hampered at the start and William Buick reported that TOLERANCE (IRE), unplaced, was slowly away from the stalls and ran green.

Race 2 - 2:55pm.**THE EVERY RACE LIVE ON RACINGTV EBF MAIDEN STAKES (CLASS 4) (GBB RACE)**

Permission was given for BALZARINI (GER) to be mounted in the chute.

Following the race, Josephine Gordon reported that BACKER BILK, unplaced, ran green.

Race 3 - 3:25pm.**THE FOLLOW @racingtv ON INSTAGRAM HANDICAP STAKES (CLASS 5)**

Permission was given for TIPSY TIGER to go early to post and for ROGUE RAIDER (USA) to wear a red hood to post.

Approaching 3 furlongs out, the winner, ASHARIBA (FR), shifted slightly left-handed, off the heels of YIPPEE, placed third, and gave a slight bump to BALLETTIC (IRE), placed fifth, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of ASHARIBA (FR).

Race 4 - 3:55pm.**THE RACINGTV PROFITS RETURNED TO RACING CLAIMING STAKES (CLASS 5)**

Permission was given for MERRIMACK to be mounted in the chute.

The winner, INDICATION COURT (IRE), appeared to show improved form compared with its previous run at Ripon on 10 May 2024, where the gelding finished twelfth of twelve, beaten by 24 $\frac{3}{4}$ lengths. It was noted that Craig Lidster could offer no explanation for the gelding's improved form. INDICATION COURT (IRE) was routine tested.

Race 5 - 4:25pm.**THE FOLLOW @racingtv ON X FILLIES' HANDICAP STAKES (CLASS 5)**

Permission was given for CYPRIOT DIASPORA to wear a red hood to post.

MRS THRUMP was keen to post. Having been checked by the Veterinary Surgeon, the filly was deemed fit to race.

Following the race, Rossa Ryan reported that MRS THRUMP, unplaced, ran too free and Clive Cox reported that SPIRIT OF THE ROSE, unplaced, was unsuited by the going on this occasion, officially described as Heavy.

Race 6 - 4:55pm.**THE SIPP CAFE BAR HANDICAP STAKES (CLASS 6)**

KALAMA SUNRISE trained by Jack Channon had entered the Parade Ring after the signal to mount had been given. After the trainer's representative was interviewed, Jack Channon was fined £140.

Following the race, Hollie Doyle reported that DESTINY'S SPIRIT, placed fifth, hung right-handed; Edward Greatrex reported that KALAMA SUNRISE, unplaced, was slowly away from the stalls and never travelled and the Veterinary Officer reported that KALAMA SUNRISE lost its left-fore shoe.

Race 7 - 5:25pm.**THE RONAN KEATING LADIES' DAY 15TH JUNE HANDICAP STAKES (CLASS 6)**

Permission was given for RINNOVATI (ITY) to wear a red hood to post.

Following the race, Brandon Wilkie reported that TEDDY BROWN, unplaced, was never travelling.
