THE NEWARK ADVERTISER APPRENTICE HANDICAP STAKES (CLASS 5) (Apprentice Training Race - Part of the Racing Excellence Series)

Permission was given for STREAK LIGHTNING (IRE) to go early to post and for QUICK AWAY to wear a red hood to the start.

STREAK LIGHTNING (IRE) unseated Sam Feilden in the chute. Having been checked by the Doctor, Feilden was deemed fit to race.

Race 3 - 3:20pm. THE B+K DBS SOUTHWELL RACECOURSE REFURB NURSERY HANDICAP STAKES (CLASS 5)

Permission was given for MONOMYTH (IRE) and LADY LIGHTNING to both wear a red hood to the start.

Race 4 - 3:55pm.

THE WOOLLEY BROS. WHOLESALE MEATS HANDICAP STAKES (CLASS 4)

THE COOPERS MARQUEES HANDICAP STAKES (CLASS 6) (DIV I)

Permission was given for MADAME FENELLA to go early to post.

Following the race, John Egan reported that WILLOW BABY (IRE), unplaced, was unsuited by being drawn wide resulting in the filly being forced to race wide.

Race 7 - 5:25pm. THE COOPERS MARQUEES HANDICAP STAKES (CLASS 6) (DIV II)

Approximately 1 ½ furlongs out MR FUNKY MONKEY, placed fifth, shifted quickly right-handed, before being corrected, moving SALLY ANNE'S DREAM, unplaced, off its intended line causing the filly to become short of room. After viewing a recording of the incident, it was found that no riding offence was





involved and had not improved the placing of MR FUNKY MONKEY.

Following the race, Andrew Breslin reported that TICKETS, placed third, was slowly away. Raul Da Silva reported that MR FUNKY MONKEY, placed fifth, hung right-handed. Lewis Edmunds reported that SALLY ANNE'S DREAM, unplaced, suffered interference 1 ½ furlongs out.
