Race 1 - 1:45pm. THE EFT SYSTEMS HANDICAP HURDLE RACE (CLASS 1) (Grade 3) (GBB RACE)

Permission was given for COME ON TEDDY (IRE) to wear a red hood to the start.

On arrival at the start, ONE NIGHT IN MILAN (IRE) was found to have a small amount of blood in its mouth. Having been examined by the Veterinary Surgeon, the gelding was deemed fit to race.

Ciaran Gethings, the rider of the winner, HOMETOWN BOY (IRE), was suspended for 2 days for using his whip above the permitted level from after the last hurdle.

An enquiry was held into interference coming out of the back straight when J'AI FROID (IRE), placed second, ridden by Max Kendrick interfered with ONE NIGHT IN MILAN (IRE), which was later pulled up, ridden by Billy Garritty, which in turn interfered with BARNAVIDDAUN (IRE), which was later pulled up, ridden by Brendan Powell, which caused interference to RESERVE TANK (IRE), which was also later pulled up, ridden by Robbie Power. Kendrick was suspended for 3 days as he had allowed his mount to drift left with insufficient correction.

Following the race, the Veterinary Officer reported that BARNAVIDDAUN (IRE), which was pulled up, bled from the nose. The Veterinary Officer further reported that a post-race examination of ONE NIGHT IN MILAN (IRE), which was pulled up, failed to reveal any abnormalities.

Race 2 - 2:25pm





THE BETWAY MERSEY NOVICES' HURDLE RACE (CLASS 1) (Grade 1) (GBB RACE)

Permission was given for JAY BEE WHY (IRE) to wear a red hood to the start, be mounted in the chute and go early to post.

Kerry Lee was fined £140 for doubly declaring BALLYBEGG (IRE) to run in THE EFT SYSTEMS HANDICAP HURDLE RACE at Aintree, and THE BETWAY MERSEY NOVICES' HURDLE RACE at Aintree, and the gelding ran in the former.

The performance of BALLYADAM (IRE), which finished fourth beaten by 43 lengths, was considered. Rachael Blackmore reported that the gelding flattened out after the third last hurdle and, in her opinion, the gelding may be feeling the effects of a long season and Henry de Bromhead reported that the race may have come too soon after Cheltenham. The Veterinary Officer reported that a post-race examination, during routine testing of BALLYADAM (IRE), failed to reveal any abnormalities.

Following the race, David Bass reported that LLANDINABO LAD, which was pulled up, stopped quickly; the Veterinary Officer reported that a post-race examination failed to reveal any abnormalities. Nico de Boinville reported that PIPESMOKER (FR), which was pulled up, ran too freely.

Race 3 - 3:00pm.

THE DOOM BAR MAGHULL NOVICES' STEEPLE CHASE (CLASS 1) (Grade 1) (GBB RACE)

THE RYANAIR STAYERS HURDLE RACE (CLASS 1) (REGISTERED AS THE LIVERPOOL HURDLE RACE) (Grade 1) (GBB RACE)

Permission was given for EMITOM (IRE) to be mounted in the chute and the gelding wore earplugs which were removed at the start.

The performance of PAISLEY PARK (IRE), which was pulled up, was considered. Emma Lavelle could offer no explanation for the gelding's performance, other than PAISLEY PARK (IRE) ran flat. The Veterinary Officer reported that a post-race examination, during routine testing of PAISLEY PARK (IRE), failed to reveal any abnormalities.

Following the race, David Bass reported that VINNDICATION (IRE), unplaced, stopped quickly; the Veterinary Officer reported that a post-race examination failed to reveal any abnormalities.

Race 5 - 4:15pm.

THE BETWAY HANDICAP STEEPLE CHASE (CLASS 1) (Grade 3) (GBB RACE)

The performance of CLOUDY GLEN (IRE), which was pulled up, was considered. Charlie Deutsch reported that CLOUDY GLEN (IRE) was never travelling and Venetia Williams could offer no further





explanation for the gelding's performance.

Following the race, Luca Morgan reported that TOP NOTCH (FR), which was pulled up, weakened quickly; the Veterinary Officer reported that a post-race examination, during routine testing of TOP NOTCH (FR), failed to reveal any abnormalities. The Veterinary Officer further reported that FAGAN, placed seventh, lost its left hind shoe.

Race 6 - 5:15pm.

THE RANDOX GRAND NATIONAL HANDICAP STEEPLE CHASE (CLASS 1) (Grade 3) (GBB RACE)

Permission was given for SUB LIEUTENANT (IRE) to be mounted in the chute and OK CORRAL (IRE) wore earplugs throughout the race.

Having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

Following the race, Richie McLernon reported that KIMBERLITE CANDY (IRE), which was pulled up, was never travelling. Richard Hobson reported that the Good to Soft going was too quick for LORD DU MESNIL (FR), which was pulled up. Tom Scudamore reported that CLOTH CAP (IRE), which was pulled up, weakened quickly and Jonjo O'Neill reported that the gelding made a respiratory noise.

Race 7 - 6:20pm.

THE WEATHERBYS nhstallions.co.uk STANDARD OPEN NATIONAL HUNT FLAT RACE (CLASS 1)(Grade 2) (GBB RACE)

Permission was given for SURE TOUCH to wear a red hood to the start.

An enquiry was held into interference approaching the wings of the second last hurdle position, when PEKING ROSE, placed second, ridden by Paddy Brennan interfered with GLENCASSLEY (IRE), placed sixth, ridden by Robbie Power. Brennan was cautioned for careless riding as he had moved right off the heels of BALCO COASTAL (FR), placed seventh, and in so doing shifted a retreating GLENCASSLEY (IRE) off its intended line.

Following the race, the Veterinary Officer reported that PRESSURE SENSITIVE (IRE), unplaced, finished lame on its right fore. James Bowen reported that MOT A MOT (FR), unplaced, was never travelling and stopped quickly; the Veterinary Officer reported that a post-race examination failed to reveal any abnormalities. Mr P. W. Mullins reported that THE GOSSIPER (IRE), unplaced, stopped quickly; the Veterinary Officer reported that a post-race examination failed to reveal any abnormalities.
