**Race 1 - 12:20pm.****THE NUNNS ISUZU SUBARU AND MAZDA GRIMSBY MAIDEN HURDLE RACE (CLASS 4) (GBB RACE)**

Permission was given for SPIRIT OF KINSALE to wear a red hood to post.

Following the race, Aaron Anderson reported that CHILLED OUT (IRE), which was pulled up, made a respiratory noise and Fergus Gillard reported that ROCHESTER BRINKS (IRE), unplaced, ran too free. The Veterinary Officer reported that SPIRIT OF KINSALE, which was pulled up, bled from the nose.

**Race 2 - 12:55pm.****THE BOOK BOXING DAY AT THE RACES EBF MARES' 'NATIONAL HUNT' MAIDEN HURDLE RACE (CLASS 4) (EBF Mares' NH Novices' Hurdle Series Qualifier) (GBB RACE)**

The sponsorship in relation to TRES BIEN, trained by Philip Kirby, did not comply with the Sponsorship Code of Conduct. Kirby was warned as to his responsibility to ensure that the correct sponsorship is carried.

**Race 3 - 1:30pm.****THE EXPLORE SHARED OWNERSHIP AT inthepaddock.co.uk NOVICES' HANDICAP STEEPLE CHASE (CLASS 4) (GBB RACE)**

**Race 4 - 2:05pm.****THE LUCAS MACHINERY HANDICAP STEEPLE CHASE (CLASS 5)**

After an initial false start, the start was effected successfully on the second attempt. However, having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

When entering the bend leaving the back straight on the second circuit, UNWANTED ATTENTION (IRE), which was pulled up, shifted quickly right-handed resulting in KANKIN, unplaced, becoming briefly tight for room and there being contact between runners, but after viewing a recording of the incident, it was found that no riding offence was involved.

The performance of THE ELECTRICIAN (IRE), which was pulled up, was considered. Mike Sowersby could offer no explanation for the gelding's performance. The Veterinary Officer examined THE ELECTRICIAN (IRE) post-race and had nothing to report.

The performance of KANKIN, which finished unplaced, was considered. Alex Hales could offer no explanation for the gelding's performance.

**Race 5 - 2:40pm.****THE IN LOVING MEMORY OF EILEEN BROUGH HANDICAP HURDLE RACE (CLASS 4)**

Permission was given for BREAD AND BUTTER (IRE) to wear a red hood to post.

Following the race, Mr Ben Sutton reported that TRIBAL GLORY (IRE), placed fifth, weakened quickly in the home straight. The Veterinary Officer examined the gelding post-race and reported a twisted right-fore shoe.

**Race 6 - 3:15pm.****THE ENJOY YOUR CHRISTMAS PARTY AT THE RACES HANDICAP HURDLE RACE (CLASS 5)**

Permission was given for NO WORRIES to wear a red hood in the parade ring.

The performance of EAST EAGLE (IRE), which was pulled up, was considered. Mike Sowersby reported that EAST EAGLE (IRE) scoped dirty post-race.

The performance of NO WORRIES, which finished unplaced, was considered. Neil Mulholland's explanation that the gelding may have been feeling the effects of a long season, was noted. The Veterinary Officer examined NO WORRIES post-race and had nothing to report.
