Fixture Note: Races 4, 6 & 7: Following concerns raised by the riders at the start regarding the low sun obscuring their vision at both hurdles in the home straight, the Stewards consulted with the Clerk of the Course and ordered that these obstacles should be by-passed for these races.

Race 5: Following concerns raised by the riders at the start regarding the low sun obscuring their vision at all three fences in the home straight, the Stewards consulted with the Clerk of the Course and ordered that these obstacles should be by-passed for this race.

### Race 1 - 4:25pm.

#### THE MANSIONBET WATCH AND BET NOVICES' HURDLE RACE (CLASS 4) (GBB RACE)

Permission was given for GLACIER FOX to be mounted in the chute and go early to post.

Jumping the first hurdle, GILBERTINA, placed fourth, veered left-handed carrying ALBORKAN (FR),

placed third, across the running of TUNED FOR POWER (IRE), which was badly hampered and later pulled up, but after viewing a recording of the incident, it was found that no riding offence was involved.

An enquiry was held to consider why Lee Edwards, the rider of TUNED FOR POWER (IRE), appeared slow to pull up when the gelding looked to have gone wrong on the approach to the fourth last hurdle. The rider was interviewed and shown recordings of the incident. Edwards explained that, although he felt TUNED FOR POWER (IRE) lose its action, he was too close to the hurdle and had another runner to his outside to pull up safely so he had to jump the flight but pulled up as soon as he could have done so. His explanation was accepted.

The performance of GILBERTINA, which started second-favourite and finished fourth, beaten by 21¾ lengths, was considered. Nick Kent's explanation that the filly ran flat on this occasion and would benefit from a freshen up, was noted. The Veterinary Officer reported that a post-race examination of GILBERTINA failed to reveal any abnormalities.

**Race 2 - 5:00pm.**

**THE MANSIONBET APP MAIDEN HURDLE RACE (CLASS 4) (GBB RACE)**

Following the race, the Veterinary Officer reported that NORVICS REFLECTION (IRE), placed third, lost its right-fore shoe.

**Race 3 - 5:30pm.**

**THE MANSIONBET PROUD TO SUPPORT BRITISH RACING HANDICAP STEEPLE CHASE (CLASS 5)**

**Race 4 - 6:00pm.**

**THE MANSIONBET BET 10 GET 20 HANDICAP HURDLE RACE (CLASS 3)**

The performance of LINELEE KING (FR), which started joint-favourite and finished fifth, was considered. Olly Murphy's explanation that the gelding ran flat on this occasion after a long season, was noted. The Veterinary Officer reported that a post-race examination of LINELEE KING (FR) failed to reveal any abnormalities.

Following the race, the Veterinary Officer reported that MR SCRUMPY, which was pulled up when entering the straight on the first circuit, bled from the nose.

**Race 5 - 6:30pm.**

**THE MANSIONBET FALLER INSURANCE HANDICAP STEEPLE CHASE (CLASS 4)**

Following the race, the Veterinary Officer reported that BALGEMMOIS (FR), which started second-favourite and finished sixth, bled from the nose.

**Race 6 - 7:00pm**

**THE MANSIONBET BEST ODDS GUARANTEED HANDICAP HURDLE RACE (CLASS 4)**

Prior to this race, Jacqueline Coward was asked to explain the reason why she was running EDEN COLLONGES (FR) here at Market Rasen on going described as Good, having reported that the gelding was unsuited by the Good going, which in her opinion, was riding softer in the back straight at Wetherby on 1 April 2021. The Stewards noted Coward's explanation that, in her opinion, the ground at Wetherby was riding softer than described and having walked the course here today felt it would be better suited to EDEN COLLONGES (FR) on this occasion.

Following the race, Jack Quinlan reported that BEAUVALLON BAY (IRE), which started co-favourite and finished seventh, was never travelling.

**Race 7 - 7:30pm.**

**THE MANSIONBET LIVE CASINO CASHBACK CONDITIONAL JOCKEYS' HANDICAP HURDLE RACE (CLASS 4)**

Approaching the omitted last hurdle, the winner, MADE FOR YOU, shifted quickly right-handed hampering THEOCRAT (IRE), placed third, carrying the gelding off its intended line, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of MADE FOR YOU.

The performance of BARNAY, which finished sixth, beaten by 55¾ lengths, was considered. The representative of Jennie Candlish's explanation that the gelding was feeling the effects of a long season and will benefit from a break, was noted. The Veterinary Officer reported that a post-race examination of BARNAY failed to reveal any abnormalities.

Following the race, Lewis Stones reported that SMART GETAWAY (IRE), placed second, was outpaced in the early stages.
