THE CORAL RACING CLUB HANDICAP HURDLE RACE (CLASS 2) (GBB RACE)

Shortly after jumping the second hurdle in the back straight, MALAKAHNA (FR), unplaced, shifted left-handed clipping the heels of PORTICELLO (FR), which later fell, causing MALAKAHNA (FR) to stumble, but after viewing a recording of the incident, it was found that no riding offence was involved.

The performance of WASHINGTON which started second favourite and was pulled up, was considered. Olly Murphy's explanation that the gelding did not appear to face the hood on this occasion was noted.

Following the race, Paddy Brennan reported that PEKING ROSE, unplaced, made a bad mistake at the third hurdle.

THE CORAL BET BUNDLES INTERMEDIATE HANDICAP HURDLE RACE (CLASS 1) (Registered as THE GERRY FEILDEN) (PREMIER HANDICAP) (GBB RACE)

Following the race, Dan Skelton's representative reported that BOOMBAWN (IRE), placed sixth, was never travelling.

Race 6 - 3:05pm.

THE CORAL GOLD CUP HANDICAP STEEPLE CHASE (CLASS 1) (PREMIER HANDICAP) (GBB RACE)

Permission was given for REMASTERED and GERICAULT ROQUE (FR) to both wear a red hood to post.

Having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

Approximately ½ furlong out, the loose horse shifted right-handed carrying the winner LE MILOS and REMASTERED, placed second, both off their intended lines, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of LE MILOS.

Harry Skelton, the rider of the winner, LE MILOS, was suspended for 7 days and fined £2,900, for using his whip above the permitted level from after jumping the second last fence.

The performance of FIDDLERONTHEROOF (IRE) which was pulled up, was considered. Joe Tizzard could offer no explanation for the gelding's performance.
