Race 1 - 5:10pm.

THE GET RACEDAY READY FILLIES' RESTRICTED NOVICE STAKES (CLASS 5) (for horses in Bands C and D) (GBB RACE)

Permission was given for PLACEHOLDER (IRE) to wear a red hood to the start.

An enquiry was held to consider interference inside the final ½ a furlong involving GO WILD, placed third, ridden by Rossa Ryan; ZARIELA, unplaced, ridden by Robert Havlin and FIBONACCI SEQUENCE (IRE), placed fourth, ridden by Callum Shepherd. Ryan was suspended for 2 days for careless riding as he shifted his mount left-handed when insufficiently clear of ZARIELA carrying the filly off its intended line and causing Havlin to take a check, which resulted in FIBONACCI SEQUENCE (IRE) being slightly tightened for room on the inside.

Following the race, Rossa Ryan reported that GO WILD, placed third, hung left-handed under pressure.

Race 2 - 5:40pm

THE FREE DIGITAL RACECARD AT raceday-ready.com CLASSIFIED STAKES (CLASS 6)

Permission was given for SUANNI and WE'RE REUNITED (IRE) to both wear a red hood to the start.

The Starter reported that PINK STRIPES was reluctant to load. Lisa Williamson was informed that the filly could not run until the day after passing a stalls test.

The performance of NEXT SECOND, which finished ninth of ten runners beaten 15 ½ lengths, was considered. It was noted that Ruth Carr could offer no explanation for the mare's performance. The Veterinary Officer examined NEXT SECOND post-race and had nothing to report.

Race 3 - 6:10pm.

THE DOWNLOAD THE RACECOURSE APP RACEDAY READY HANDICAP STAKES (CLASS 6)

Permission was given for THE BAY WARRIOR (IRE), CHAGALL (IRE) and BAY OF NAPLES (IRE) to all go early to post; for MR BOSON to go early to post and to be mounted in the chute; for DILLYDINGDILLYDONG to wear a red hood to the start.

Following the race, Elle-May Croot reported that ANOTHER BEAUTIFUL, unplaced ran too free. Billy Loughnane reported that SEXY REXY (IRE), unplaced, stopped quickly; the Veterinary Officer examined the filly post-race and had nothing to report.

Race 4 - 6:40pm.

THE DOWNLOAD THE RACEDAY READY APP HANDICAP STAKES (CLASS 6)

Rounding the home bend ANNA OF SAXONY, placed fourth, became momentarily short of room between VIRTUAL HUG (IRE), placed second, and FOND FAREWELL (IRE), unplaced, which resulted in the filly becoming unbalanced. After viewing a recording of the incident, it was found that no riding no offence was involved and that it had not improved the placing of VIRTUAL HUG (IRE).

Following the race, Rossa Ryan reported that ANNA OF SAXONY, placed fourth, ran too free. Hollie Doyle reported that CASA LUNA (IRE), unplaced, stopped quickly; the Veterinary Officer examined the mare post-race and had nothing to report.

Race 5 - 7:10pm.

THE GET THE INSIDE TRACK WITH raceday-ready.com HANDICAP STAKES (CLASS 5)

Permission was given for SO OBSESSED (IRE) to wear a red hood to the start and for SPIRIT LA ADELITA to go early to post.

Jimmy Sullivan, the rider of SPIRIT LA ADELITA, was unseated leaving the stalls. The rider was interviewed and shown recordings of the incident. It was found that the incident was accidental and was caused by the filly stumbling.

Following the race, Joey Haynes reported that UNAVAILABLE, placed third, hung right-handed throughout.

Race 6 - 7:40pm.

THE DOWNLOAD THE RACEDAY READY APP CLASSIFIED STAKES (CLASS 6) (DIV I)

Permission was given for INDEPENDENT BEAUTY to go early to post.

The winner, GLORY CALL (IRE) appeared to show improved form compared with its previous run at Newcastle on 27 June 2024 where the gelding finished last of fourteen runners beaten 21¾ lengths. The explanation given by the representative of Ollie Pears that the GLORY CALL (IRE) had appreciated the slight drop in grade on this occasion was noted. The gelding was routine tested.

Shortly after turning into the home straight the winner, GLORY CALL (IRE) drifted right-handed before being corrected, intimidating INDEPENDENT BEAUTY, placed fourth, off its intended line who in turn carried MY KIND OF GIRL (FR), placed second, off its intended line causing that filly to give a bump to PERFECT FOCUS (IRE), placed third, as a result. After viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of GLORY CALL (IRE).

Following the race, Sam Feilden reported HARD SOLUTION, unplaced, was slowly away.

Race 7 - 8:10pm.

THE DOWNLOAD THE RACEDAY READY APP CLASSIFIED STAKES (CLASS 6) (DIV II)

Shortly after the start a free running WAR ZONE (IRE), unplaced, shifted quickly right-handed before being corrected, giving a bump to and moving KANGAROO (IRE), unplaced, off its intended line, which in turn carried MIDNIGHT FLAME (IRE), unplaced, off its intended line. After viewing a recording of the incident, it was found that no riding offence was involved.

Rounding the bend leaving the back straight, the free running SASSY SOPRANO (IRE), placed third, lugged slightly left-handed causing CALL ME THE BREEZE, unplaced, to be tightened for room on the rail and its rider to take a check, resulting in REVE DE MAGRITTE (FR), placed fifth, to be checked and ALIBI WARNING (IRE), placed second, to be slightly hampered. After viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of SASSY SOPRANO (IRE).

Following the race, William Cox reported that MIDNIGHT FLAME (IRE), unplaced, suffered interference shortly after leaving the stalls. Rob Hornby reported that CALL ME THE BREEZE, unplaced, suffered interference approximately 4 furlongs out. Zak Wheatley reported that SASSY SOPRANO (IRE), placed third, hung left-handed throughout.

Race 8 - 8:40pm.

THE TIPS FOR EVERY RACE AT raceday-ready.com HANDICAP STAKES (CLASS 6)

Permission was given for KEEN INTEREST (IRE) and SNOW EAGLE to both wear a red hood to the start.

An enquiry was held to consider interference turning into the home straight involving SOLO SOLATAIRE (IRE), unplaced, ridden by Rossa Ryan; SOVERAINE (IRE), placed fourth, ridden by Billy Loughnane the winner, NEWFANGLED (IRE), ridden by Trevor Whelan; SNOW EAGLE, unplaced, ridden by Lewis Edmunds. The interference was found to be accidental as when turning in SOVERAINE (IRE) pricked its ears and shifted right-handed, carrying NEWFANGLED (IRE), who was improving its position to the outside, off its intended line. This in turn slightly hampered SNOW EAGLE, unplaced, and further gave a bump to SOLO SOLATAIRE (IRE).
