The winner, MANOR PARK, appeared to show an improvement in form compared with its previous run at Taunton on 21 April 2021, where the gelding finished eleventh of thirteen, beaten 47 lengths. Brian Barr





explained that MANOR PARK was ridden more positively on this occasion. The gelding was routine tested.

Following the race, James Bowen reported that SHUTTHEGATE (IRE), which was pulled up, was never travelling and John Spearing's representative reported that the gelding was unsuited by the going, which was officially described as Good, Good to Firm in Places on this occasion, and would prefer an easier surface. The Veterinary Officer reported that YOUVEBROKENMYDREAM, placed second, lost its right fore shoe.
