**Race 1 - 4:37pm.****THE UNIBET SUPPORTING SAFER GAMBLING FILLIES' NOVICE STAKES (CLASS 5) (GBB RACE)**

Permission was given for LUNA BAY and WHATAMOON to wear a red hood to post.

Following the race, Saffie Osborne reported that DEBRADINI (USA), unplaced, was slowly away and Adam Farragher reported that MISSION IMPOSSIBLE, unplaced, hung right-handed in the straight.

**Race 2 - 5:11pm.****THE UNIBET ZERO% MISSION NURSERY HANDICAP STAKES (CLASS 5)**

Permission was given for PARODA DIVA (IRE) to wear a red hood to post.

Following the race, George Scott's representative reported that JACK THE TOOTH, placed fifth, hung right-handed throughout.

**Race 3 - 5:48pm**

**THE UNIBET MORE EXTRA PLACE RACES HANDICAP STAKES (CLASS 4) (London Mile Series Qualifier) (DIV I)**

Following the race, Oliver Searle reported that TADREEB (IRE), unplaced, stumbled leaving the stalls, Robert Havlin reported that RACINGBREAKS RYDER (IRE), unplaced, ran too free and Sean Dylan Bowen reported that METAVERSE (IRE), unplaced, also ran too free.

**Race 4 - 6:23pm.**

**THE UNIBET MORE EXTRA PLACE RACES HANDICAP STAKES (CLASS 4) (London Mile Series Qualifier) (DIV II)**

Permission was given for MILETUS (IRE), BELIEVE THE STORM (IRE) and AL WAQIDI to wear a red hood to post.

The sponsorship in relation to DEBORA'S DREAM (IRE), trained by Jennie Candlish did not comply with the Sponsorship Code of Conduct. Candlish was warned as to her responsibility to ensure that the correct sponsorship is carried.

Following the race, Paddy Bradley reported that KALAMUNDA, unplaced, was reluctant to race, causing the gelding to be slowly into stride; Rob Hornby reported that GIANT, placed fifth, stumbled leaving the stalls; Hector Crouch reported that BELIEVE THE STORM (IRE), placed second, was slowly away and Tommie Jakes reported that KOY KOY, unplaced, was slowly away.

**Race 5 - 6:58pm.**

**THE UNIBET 40,000+ LIVE STREAMED EVENTS HANDICAP STAKES (CLASS 3) (GBBPLUS RACE)**

Permission was given for HIGH ORDER, KITTY FURNIVAL (IRE), SIEMPRE ARTURO and CHARMAINE to wear a red hood to post and for ARQOOB (IRE) to wear a hood in the parade ring.

The sponsorship in relation to FOREST GATE (IRE), trained by Eve Johnson Houghton did not comply with the Sponsorship Code of Conduct. Johnson Houghton was warned as to her responsibility to ensure that the correct sponsorship is carried.

Following the race, Olivia Tubb reported that WAY OF LIFE, unplaced, reared as the start was effected and Rhys Clutterbuck reported that FOREST GATE (IRE), unplaced, never travelled. The Veterinary Officer examined FOREST GATE (IRE), post-race and found the gelding to be lame on its right-fore.

**Race 6 - 7:33pm.**

**THE TRY UNIBET'S NEW IMPROVED ACCA BOOSTS HANDICAP STAKES (CLASS 5) (Jockey Club Grassroots and London Sprint Series Qualifier) (DIV**

Permission was given for MASSIMO BLUE to wear a red hood to post.

The winner, ICONIC TIMES appeared to show improved form compared with its previous run at Sandown Park on 13 June 2025, where the gelding finished seventh of eleven runners, beaten 7 ½ lengths. The representative of Heather Main's explanation that the gelding appreciated the drop back in trip to 6

furlongs and a return to Kempton Park where it was a course and distance winner previously was noted. ICONIC TIMES was routine tested.

Racing into the first bend, BALLSGROVE BOY, placed second, was forced to be steadied and switched right-handed by its rider off the heels of a free running TEMPEST STAR (IRE), unplaced, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, John Butler reported that TEMPEST STAR (IRE), unplaced, did not appreciate the first-time blinkers and as a result, ran too free. The Veterinary Officer reported that WILD EMBERS (IRE), unplaced, finished lame on its right-fore.

#### **Race 7 - 8:08pm.**

##### **THE TRY UNIBET'S NEW IMPROVED ACCA BOOSTS HANDICAP STAKES (CLASS 5) (Jockey Club Grassroots and London Sprint Series Qualifier) (DIV**

Permission was given for ORNATELY to wear a red hood to post, for NORDIC GAMES and AZUINTEJUNGLE to be mounted on the course and for THE THAMES LADY (IRE) to go to post early.

An enquiry was held to consider interference shortly after the start involving, SON OF WIND (IRE), placed fourth, ridden by Tommie Jakes and NORDIC GAMES, unplaced, ridden by Sean Kirrane. Jakes was suspended for 2 days for careless riding as he had allowed his mount to drift right-handed when insufficiently clear of NORDIC GAMES forcing Kirrane to take check and be taken off his intended line.

An enquiry was held to consider interference rounding the first turn involving the winner, AZUINTEJUNGLE, ridden by Faye McManoman and NORDIC GAMES, unplaced, ridden by Sean Kirrane. McManoman was suspended for 2 days for careless riding as she had allowed her mount to drift right-handed when insufficiently clear of NORDIC GAMES causing that runner to be short of room and Kirrane to have to take a check.

Following the race, Callum Hutchinson reported that TAKTEEK, unplaced, was slowly away and Paddy Bradley reported that THE THAMES LADY (IRE), unplaced, ran too free.

#### **Race 8 - 8:43pm.**

##### **THE TRY UNIBET'S NEW SMARTVIEW RACECARDS HANDICAP STAKES (CLASS 5) (London Sprint Series Qualifier)**

Permission was given for GENERAL ASSEMBLY (IRE) to go to post early wearing a red hood and for BILL PLUMB (IRE) to wear a red hood to post.

Approximately half a furlong out, DELAGATE THIS LORD, placed fourth, shifted right-handed away from its rider's whip, before being corrected, which caused HIERARCHY (IRE), placed second, to be taken off its intended line and in turn resulted in a weakening PAPABELLA, unplaced, having to be steadied, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of DELAGATE THIS LORD.

Following the race, Jim Crowley reported that THURSDAY'S CHILD, placed fifth, was denied a clear run

approximately two furlongs out, Rob Hornby reported that PAPABELLA, unplaced, ran too free and Elizabeth Gale reported that ALCAZAN, unplaced, stopped quickly. The Veterinary Officer reported that ALCAZAN had been struck into on its left-hind.
