Race 1 - 1:00pm.

THE FOLLOW @racingtv ON TWITTER APPRENTICE HANDICAP STAKES (CLASS 6) (Racing Excellence Apprentice Training Series)

Dean Ivory had obtained prior permission from the BHA to run NICKY BABY (IRE) partially shod.

The Starter reported that CAPTAIN SEDGWICK (IRE) was reluctant to load. John Spearing was informed that the mare could not run until the day after passing a stalls test.

Approaching 2 furlongs DEW YOU BELIEVE (IRE), placed fourth, shifted left-handed briefly inconveniencing the weakening GRANDSTAND (IRE), unplaced, but after viewing a recording of the incident, it was found that no riding offence was involved and had not improved the placing of DEW YOU BELIEVE (IRE).

Following the race, Erika Parkinson reported that DEW YOU BELIEVE (IRE), placed fourth, was restless in the stalls. The representative of Richard Price reported that GRANDSTAND (IRE), unplaced, was unsuited by the Good Going on this occasion and would prefer a quicker surface.

Race 2 - 1:35pm.

THE BET AT racingtv.com NOVICE STAKES (CLASS 5) (GBB RACE)

Permission was given for HEBRIDES (IRE) to wear a red hood to the start.

Inside the final furlong GREENBARN, unplaced, shifted quickly left-handed before being corrected causing the rider of JENEVER, unplaced, to take a check, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Alistair Rawlinson reported that AN ANGEL'S DREAM (FR), unplaced, was outpaced and Silvestre De Sousa reported that GREENBARN, unplaced, weakened quickly approaching the furlong marker.

Race 3 - 2:10pm.

THE JOIN RACING TV NOW HANDICAP STAKES (CLASS 4) (Jockey Club Grassroots Sprint Series Qualifier)

Permission was given for SENECA CHIEF to wear a red to the start.

Following the race, Liam Wright reported that FANTASY MASTER, placed second, jumped awkwardly from the stalls.

Race 4 - 2:45pm.

THE racingtv.com HANDICAP STAKES (CLASS 5) (Jockey Club Grassroots Stayers Series Qualifier)

Permission was given for LAWMANS BLIS (IRE) to wear a red hood in the parade ring only.

Pat Dobbs, the rider of the winner, GRAND SCHEME (IRE), was suspended for 2 days for using his whip above the permitted level from inside the 2 furlong marker.

Following the race, George Downing reported that MOUNT OLYMPUS, unplaced, was slowly away and

weakened quickly; the Veterinary Officer reported a post-race examination of the gelding failed to reveal any abnormalities.

Race 5 - 3:20pm.

THE WATCH ON RACING TV HANDICAP STAKES (CLASS 5) (A Jockey Club Grassroots Middle Distance Qualifier)

An enquiry was held to consider the placings in this race after interference inside final half furlong involving AMALFI BAY, placed second, ridden by Thomas Greatrex and RICH DREAM (IRE), placed fourth, ridden by Silvestre De Sousa. The Stewards considered that the interference had not improved AMALFI BAY's placing as although RICH DREAM (IRE) became short for room against the rail and had to be checked, the gelding was weakening at the time of the interference. The Stewards further considered that the momentum lost as a result of the interference was less than the three length margin between the runners at the line. Greatrex was suspended for 3 days for careless riding as he allowed his mount to drift left-handed towards the rail without sufficient correction causing De Sousa to be tightened and have to take a check.

An enquiry was held to consider interference half way down the back straight involving TWO BROTHERS, placed fifth, ridden by Joanna Mason and MR MARVLOS (IRE), unplaced, ridden by Pat Dobbs. The interference was found to be accidental as TWO BROTHERS drifted marginally left-handed at the same time as MR MARVLOS latched on causing Dobbs to take a slight check.

Following the race, Pat Dobbs reported that MR MARVLOS (IRE), unplaced, hung right-handed.

Race 6 - 3:55pm.

THE RACING TV PROFITS RETURNED TO RACING HANDICAP STAKES (CLASS 5) (A Jockey Club Grassroots Mile Series Qualifier)

Having reviewed the start the Stewards were satisfied that HELENE had refused to race and was deemed to be a runner.

Shortly after turning into the home straight MURPHY'S DREAM, unplaced, shifted quickly left-handed under the whip before being quickly corrected bumping AUSSIE BANKER, placed sixth, resulting in the rider of BOND BOY, unplaced, to take a check, but after viewing a recording of the incident, it was found that no riding offence was involved.

An enquiry was held to consider the placings in this race after interference inside the final furlong when the winner, ERMIN STREET (IRE) ridden by Tyler Saunders interfered with NOBLE MARK (IRE), placed second, ridden by Luke Morris. Kieran O' Neill, the rider of NIGHT ARC, placed third, was also interviewed and shown recordings of the incident. The Stewards considered that the interference had improved ERMIN STREET (IRE)'s placing as NOBLE MARK was carried notably off its intended line resulting in a loss of ground which was considered to be more than the nose between the runners at the line. The placings were revised as follows: First; NOBLE MARK (IRE), Second: ERMIN STREET (IRE). Saunders was suspended for 2 days for careless riding as he had failed to take sufficient steps to prevent his mount from drifting several horse widths left without sufficient or timely correction carrying NOBLE MARK (IRE) off its

intended line resulting in the rider of NIGHT ARC having to take a slight check.

Following the race, Theodore Ladd reported that BOND BOY, unplaced, ran too free and Kieran O'Neill reported that NIGHT ARC, placed third, hung left-handed. The representative of Richard Hughes reported that AUSSIE BANKER, placed sixth, was unsuited by the track.

Race 7 - 4:30pm.

THE VISIT racingtv.com HANDICAP STAKES (CLASS 5)

Inside the last 2 furlongs, BRIGHT BLUE (IRE), placed sixth, shifted quickly left-handed at the same time as the winner MIDNIGHT TRAIN edged marginally right-handed causing GEOPOLITIC (IRE), unplaced, to be slightly eased, but after viewing a recording of the incident, it was found that no riding offence was involved.

Halfway down the back straight, YOUNG WINSTON, placed third, shifted left-handed taking KINRARRA, placed fifth, marginally off its intended line causing the rider of RAMPOLDI PLAN (USA), placed second, to take a slight check, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the races, Luke Morris reported that BRIGHT BLUE (IRE), placed sixth, hung left-handed, Daniel Muscutt reported that DRAWING CLOCKS, unplaced, weakened quickly; the Veterinary Officer reported a post-race examination of the gelding failed to reveal any abnormalities. Alistair Rawlinson reported that JENNYS JACK DANIEL, unplaced, was never travelling.
