Race 1 - 2:00pm.**THE MANSIONBET NURSERY HANDICAP STAKES (CLASS 5) (Jockey Club Grassroots Nursery Qualifier)**

The Veterinary Officer reported that upon inspection, COASTAL MIST (IRE) was grey and not bay as published in the racecard.

Following the race, Adam McNamara reported that EXECLUSIVE (IRE), unplaced, jumped awkwardly from the stalls.

Race 2 - 2:30pm.**THE MANSIONBET BRITISH EBF NOVICE MEDIAN AUCTION STAKES (CLASS 5)**

Following the race, Trevor Whelan reported that SOPHAR SOGOOD (IRE), unplaced, was slowly away.

The Sampling Officer reported that Clifford Lee had only been able to provide a partial urine sample and

now wished to leave the course in order to ride at another meeting. The rider and the Sampling Officer were interviewed. Having heard their evidence, the Stewards granted him an exemption from providing a sample.

Race 3 - 3:00pm.

THE MANSIONBET BEATEN BY A HEAD HANDICAP STAKES (CLASS 5) (A Jockey Club Grassroots Stayers Series Qualifier)

On the run to the line, ROAD TO PARIS (IRE), placed second, lugged right before being quickly corrected, bumping the winner, EYE OF THE STORM (IRE), but after viewing a recording of the incident, it was found that no riding offence was involved.

Race 4 - 3:30pm.

THE BRITISH STALLION STUDS EBF CONDITIONS STAKES (CLASS 3)

Following the race, Dougie Costello reported that TARBOOSH, unplaced, stopped quickly and the Veterinary Officer reported that a post-race examination revealed the gelding was showing signs of a prolonged recovery.

Race 5 - 4:00pm.

THE MANSIONBET HANDICAP STAKES (CLASS 5) (Jockey Club Grassroots Sprint Series Qualifier)

Permission was given for TADAANY (IRE) to go early to post.

Following the race, Megan Nicholls reported that HANATI (IRE), placed fifth, stopped quickly and the Veterinary Officer reported that a post-race examination of the filly failed to reveal any abnormalities.

Race 6 - 4:30pm.

THE MANSIONBET BEST ODDS GUARANTEED HANDICAP STAKES (CLASS 6)

An enquiry was held to consider why Sebastian Woods, who was declared to ride HOLLANDER, and was required to provide a urine sample, had failed to arrive. The Clerk of the Scales, the Sampling Officer, a Valet and a representative of Alexandra Dunn, the trainer of HOLLANDER, were interviewed. The Clerk of the Scales explained that he had been informed by Dunn's representative that Woods had been unable to ride due to being ill. The matter was forwarded to the Head Office of the British Horseracing Authority for further consideration.

Permission was given for CUPID'S ARROW (IRE) to go early to post.

An enquiry was held to consider why TAN, ridden by Pierre-Louis Jamin and trained by Michael Appleby, had arrived late at the start, causing the race to be 7 minutes late off. The rider and the trainer were interviewed. Jamin was suspended for 1 day and Appleby was fined £140.

Race 7 - 5:00pm

THE MANSIONBET APPRENTICE HANDICAP STAKES (CLASS 6)

Permission was given for MAJESTIC STONE (IRE) to go early to post and MOVIE STAR (GER) wore earplugs which were removed at the start.

Approximately 2 furlongs out, MOVIE STAR (GER), placed sixth, edged right causing TILSWORTH LUKEY, placed third, to be briefly checked in its run, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Harry Russell reported that MAJESTIC STONE (IRE), placed fifth, was slowly away and Toby Eley reported that SNOOKER JIM, unplaced, had no more to give and the Veterinary Officer reported that a post-race examination of the gelding failed to reveal any abnormalities.
