Race 1 - 6:40pm.**THE RIPON RACES GENTLEMAN'S EVENING 6TH AUGUST FILLIES' NOVICE AUCTION STAKES (CLASS 5)
(PLUS 10 RACE)**

Approaching the final furlong, REQUIEMS DREAM (IRE), placed second, hung left-handed causing Jack Garrity, the rider of KENDRED SOUL (IRE), placed third, to become tightened for room against the running rail and to be momentarily eased, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of REQUIEMS DREAM (IRE).

Following the race, Franny Norton reported that REQUIEMS DREAM (IRE), placed second, hung left-handed. Conor McGovern reported that WRONGROADTOMAYO, which finished last of the seven runners, was slowly away. The representative for Archie Watson reported that MY MOTIVATE GIRL, unplaced, became unbalanced by the undulations at Ripon on this occasion and the Veterinary Officer reported that a post-race examination, during routine testing, failed to reveal any abnormalities.

Race 2 - 7:10pm.**THE MIDDLEHAM TRAINERS ASSOCIATION HANDICAP STAKES (CLASS 5)**

Following the race, Rachel Richardson reported that MAC AILEY, placed sixth, reared as the stalls opened resulting in the gelding being very slowly away and Cam Hardie reported that GLACEON (IRE), placed eighth, was denied a clear run approaching the final furlong. John Norton reported that MAGIC SHIP (IRE), which finished last of the fourteen runners, was unsuited by the Good to Firm, Good in Places

ground on this occasion and would prefer an easier surface.

Race 3 - 7:40pm.

THE SKY SPORTS RACING VIRGIN 535 HANDICAP STAKES (CLASS 4)

Following the race, the representative for Charlie Fellowes reported that MANTON WARRIOR (IRE), placed fourth, became unbalanced by the undulations at Ripon on this occasion and Duran Fentiman reported that AGRAVAIN, placed fifth, ran flat.

THE RIPON, YORKSHIRE'S GARDEN RACECOURSE HANDICAP STAKES (CLASS 3)

Following the race, Jason Ward reported that KING'S PAVILION (IRE), placed sixth, became unbalanced by the undulations at Ripon on this occasion and the Veterinary Officer reported that a post-race examination of the gelding failed to reveal any abnormalities.

Race 5 - 8:40pm.

THE TOPSPORT EQUISAND HANDICAP STAKES (CLASS 5)

Permission was given for BALDWIN (IRE) to go early to post.

The winner PINARELLA (FR), appeared to show improved form, compared with its previous run at Carlisle on 31 May 2019 where the filly finished eighth of the eleven runners, beaten by 18 ¼ lengths. The representative for Ben Haslam's explanation that the filly appreciated the Good to Firm, Good in places ground on this occasion, having finished unplaced on Soft ground last time out, was noted.

Following the race, Daniel Tudhope reported that FAIRY FAST (IRE), which started second favourite and finished last of the thirteen runners, was slowly away and the Veterinary Officer reported that a post-race examination, during routine testing, failed to reveal any abnormalities. Cam Hardie reported that ALLSFINEANDANDY (IRE), unplaced, became unbalanced by the undulations at Ripon on this occasion.

Race 6 - 9:10pm.
