Race 1 - 2:00pm.

THE DANNY MCNAB BOOKMAKERS BRITISH EBF RESTRICTED NOVICE STAKES (CLASS 4) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (DIV I) (GBB RACE)

Permission was given for both ARDENNES (IRE) and CAYMAN TAI (IRE) to wear a red hood to post.

Following the race, Alistair Rawlinson reported that PAPPA LOUIS, unplaced, hung both ways and ran green.

Race 2 - 2:32pm.**THE DANNY MCNAB BOOKMAKERS BRITISH EBF RESTRICTED NOVICE STAKES (CLASS 4) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (DIV II) (GBB RACE)**

GLORIOUS (IRE) unseated Gina Mangan on the way to post. Having been checked by the Veterinary Surgeon and Doctor, both were deemed fit to race.

Following the race, Gina Mangan reported that GLORIOUS (IRE), unplaced, jumped awkwardly from the stalls.

Race 3 - 3:02pm.**THE RADCLIFFE & CO HANDICAP STAKES (CLASS 6) (DIV I)**

Permission was given for LIEGE (IRE) to wear a red hood and go early to post.

Leaving the stalls, the winner MOE'S LEGACY jumped left-handed at the same time as MATCH ANTHEM (IRE), placed fifth, jumped right-handed causing MISS IDDUN (IRE), placed fourth, to become short for room between runners, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of MOE'S LEGACY.

Following the race, Rossa Ryan reported that HOT FRONT (IRE), unplaced, was slowly away and William Carver reported that LIEGE (IRE), unplaced, ran too free and stopped quickly. The Veterinary Officer examined the gelding post-race and had nothing to report.

Race 4 - 3:37pm.**THE RADCLIFFE & CO HANDICAP STAKES (CLASS 6) (DIV II)**

Permission was given for MELISENDE to wear a red hood to post.

Approximately 1 furlong out, KINGWOOD QUEEN (FR), placed third, lugged slightly right-handed despite the rider's best efforts causing CROCUS TIME (IRE), placed fourth, to be momentarily short for room, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of KINGWOOD QUEEN (FR).

Following the race, Alec Voikhansky reported that CROCUS TIME (IRE), placed fourth, was denied a clear run approximately 1 furlong out, Olivia Tubb reported that THUNDEROUS LOVE, unplaced, hung left-handed in the closing stages and Dylan Hogan reported that TROIS BLANCS, unplaced, was outpaced throughout.

Race 5 - 4:07pm.**THE RADCLIFFE & CO NOVICE STAKES (CLASS 4) (GBB RACE)**

JODHPUR BLUE (FR), trained by Charles Hills, ran without its left-hind shoe as the trainer had not indicated at declaration stage that the gelding should be withdrawn in the event of losing a shoe on the

way to post.

PERENNIAL reversed into the rail at the start. Having been checked by the Veterinary Officer, the gelding was deemed fit to race.

Following the race, JODHPUR BLUE (FR), unplaced, stumbled inside the final ½ furlong. The Veterinary Officer examined JODHPUR BLUE (FR) post-race and had nothing to report other than the gelding had lost its right-hind shoe.

Race 6 - 4:37pm.

THE MADAR CORPORATION MAIDEN STAKES (CLASS 4) (GBB RACE)

Permission was given for both LIAM SWAGGER and PAGAN SUN (FR) to wear a red hood to post.

Following the race, Charles Bishop reported that BE LIKE PUMPKIN, unplaced, was slowly away, Hollie Doyle reported that LIAM SWAGGER, placed second, hung left-handed on the top bend and William Cox reported that TANGO SUNSET (IRE), unplaced, ran green. William Buick reported that STEEL TIGER (IRE), unplaced, stopped quickly and the representative of Simon and Ed Crisford reported that STEEL TIGER (IRE) was unsuited by the Going on this occasion, which was officially described as Good to Firm and would prefer a softer surface. The Veterinary Officer examined the colt post-race and had nothing to report.

Race 7 - 5:07pm.

THE SORVIO INSURANCE BROKERS MARGADALE FILLIES' HANDICAP STAKES (CLASS 4)

Permission was given for both ALHATTAN (IRE) and PRATIGYA to wear a red hood to post.

Leaving the stalls, the winner QUIETNESS jumped right-handed at the same time as ALHATTAN (IRE), placed second, jumped left-handed causing XIOMARA (IRE), placed fifth, to become short for room and receive a bump but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of QUIETNESS or ALHATTAN (IRE).

Race 8 - 5:42pm.

THE SHIPSEYS MARQUEES HANDICAP STAKES (CLASS 5)



Permission was given for SHE'S CENTIMENTAL (USA) to wear a red hood to post.

An enquiry was held to consider interference inside the final furlong when STRIKE, placed third ridden by Rob Hornby interfered with BRIGHT (IRE), unplaced, ridden by Finley Marsh and SHE'S CENTIMENTAL (USA), unplaced, ridden by David Egan. The interference was found to be accidental as STRIKE moved quickly left-handed away from LIHOU, placed second, causing BRIGHT (IRE) to be short for room between STRIKE and SHE'S CENTIMENTAL (USA).

Following the race, Richard Kingscote reported that ULTRAMARINE (IRE), unplaced, was denied a clear run for a sustained period over the final furlong.
