Race 1 - 4:50pm. THE HIGHCLERE CASTLE HORSE FEEDS 'CARNARVON' HANDICAP STAKES (CLASS 6) (FOR GENTLEMAN AMATEUR JOCKEYS)

Permission was given for BALLET BLANC to go early to post and for TYPICAL MAN to wear a red hood to post.

Following the race, Mr Nathan Seery reported that TYPICAL MAN, placed fifth, was slowly away. The Veterinary Officer reported that HELLAVAPACE, unplaced, bled from the nose.

<u>Race 2 - 5:20pm.</u> <u>THE RUMBLE INTHEJUNGLE STANDING AT NORMAN COURT STUD BRITISH EBF NOVICE STAKES (CLASS 4)</u> (DIV I)

Permission was given for ZABRISKIE POINT to wear a red hood to post.

An enquiry was held to consider the placings in this race after interference a furlong out when the winner, JUBILEE WALK, ridden by Cieren Fallon interfered with CAJETAN, placed second, ridden by James Doyle. The Stewards could not be satisfied that had CAJETAN had an uninterrupted run to the line it would





have finished in front of JUBILEE WALK as following the initial interference a furlong out both horses independently continued to drift left-handed in the closing stages, there was no contact between them, there was no effect on the momentum of CAJETAN who appeared to drift further left-handed of his own accord in the final ½ furlong, and JUBILEE WALK appeared to be always holding CAJETAN on the run to the line. The interference was found to be accidental as JUBILEE WALK drifted left-handed despite the rider's best efforts to straighten him.

Following the race, Cieren Fallon reported that the winner, JUBILEE WALK, hung left-handed under pressure.

Race 3 - 5:53pm.

THE RUMBLE INTHEJUNGLE STANDING AT NORMAN COURT STUD BRITISH EBF NOVICE STAKES (CLASS 4) (DIV II)

An enquiry was held to consider interference shortly after the start when AMERICAN BAY, placed second, ridden by David Probert interfered with IPPOTHEOS (IRE), unplaced, ridden by Mohammed Tabti. The interference was found to be accidental as a free running AMERICAN BAY moved left-handed after leaving the stalls before being quickly corrected.

An enquiry was held to consider interference shortly after the start when NUKANAN (IRE), placed third, ridden by Raul Da Silva interfered with MEET ME IN MERAKI, unplaced, ridden by Phil Dennis, AMERICAN BAY, placed second, ridden by David Probert and IPPOTHEOS (IRE), unplaced, ridden by Mohammed Tabti. Raul Da Silva was suspended for 3 days for careless riding as he allowed his mount to drift right-handed when insufficiently clear of MEET ME IN MERAKI causing Dennis to drift right-handed into the path of AMERICAN BAY which in turn interfered with IPPOTHEOS (IRE).

Following the race, Phil Dennis reported that MEET ME IN MERAKI, unplaced, ran too free, and Raul Da Silva reported that NUKANAN (IRE), placed third, hung right-handed.

<u>Race 4 - 6:23pm.</u> THE ROGER JOWETT MEMORIAL BRITISH EBF FILLIES' NOVICE STAKES (CLASS 4) (DIV I) (GBB RACE)

Permission was given for ALL AGLEAM and RINNOVATI (ITY) to wear a red hood to post.

Eve Johnson Houghton had obtained prior permission from the BHA to run RINNOVATI (ITY) with no hind shoes.

Following the race, William Cox reported that LITTLE WHITE DOVE (IRE), unplaced, jumped right-handed leaving the stalls and ran green thereafter. George Downing reported that RINNOVATI (ITY), unplaced, hung left-handed throughout and Daniel Muscutt reported that ZOUMOON, placed second, hung left-handed under pressure.

<u>Race 5 - 6:53pm.</u> THE ROGER JOWETT MEMORIAL BRITISH EBF FILLIES' NOVICE STAKES (CLASS 4) (DIV II) (GBB RACE)





Permission was given for RAQIYA (IRE) to wear a red hood to post.

The Veterinary Officer reported that a representative of Ralph Beckett had presented the incorrect horse at the racecourse stables for identification in place of SO LOGICAL which was declared to run in the 6:53pm race. Beckett was interviewed via telephone. Having heard his evidence, the Stewards referred the matter to the Head Office of the British Horseracing Authority.

An enquiry was held to consider interference inside the final 1 ½ furlongs when MISS IDUNN (IRE), placed fourth, ridden by Sean Levey interfered with CASSIAS COMET, unplaced, ridden by Hayley Turner. Levey was cautioned for careless riding as he allowed his mount to drift slightly right-handed when insufficiently clear, leaving a weakening CASSIAS COMET briefly short of room.

Race 6 - 7:23pm. THE HIGHCLERE CASTLE "THE PERFECT GIN" HANDICAP STAKES (CLASS 6)

Race 7 - 7:53pm. THE HIGHCLERE CASTLE GIN HANDICAP STAKES (CLASS 5)

Permission was given for KRACKING to go early to post wearing a red hood and for AZAHARA PALACE and MAREMMA to wear a red hood to post.

The performance of WAR CHANT (IRE) which started favourite and finished unplaced, was considered. The representative of Rae Guest's explanation that the gelding was unsuited by the going, which was officially described as Good on this occasion, and would prefer a quicker surface was noted. The Veterinary Officer examined the gelding post-race and had nothing to report.

Following the race, Daniel Muscutt reported that GARRICK PAINTER (IRE), unplaced, stopped quickly, the Veterinary Officer examined the gelding post-race and had nothing to report.

<u>Race 8 - 8:23pm.</u> THE EDWARDS FORD, FORAY MOTOR GROUP HANDICAP STAKES (CLASS 6)

Following the race, Jim Crowley reported that NELLIE MOON, placed third, was denied a clear run 2 furlongs out.
