### **Race 1 - 5:15pm.**

#### **THE COOPERS MARQUEES BRITISH EBF RESTRICTED MAIDEN STAKES (CLASS 4) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (GBB RACE)**

Entering the first bend, a free-running GALAXY GAZER, placed third, hung right-handed across the heels of the winner JUST JANET, when being restrained to take a lead. However, after viewing a recording of the incident, it was found that no riding offence was involved.

Approximately 3 furlongs out, the winner JUST JANET edged left-handed carrying GALAXY GAZER, placed third, off its intended line. However, after viewing a recording of the incident, it was found that no riding offence was involved, and that it had not improved the placing of JUST JANET.

Just inside 1 furlong out, GALAXY GAZER, placed third, changed leads and became unbalanced, causing the filly to shift right-handed and make light contact with the winner JUST JANET. However, after viewing a recording of the incident, it was found that no riding offence was involved.

### **Race 2 - 5:50pm.**

#### **THE JM FINN WEALTH MANAGEMENT RESTRICTED NOVICE STAKES (CLASS 6) (for horses in Bands C and D)**

The Starter reported that DAN DE MAN CAN refused to enter the stalls and was withdrawn at 5:52pm. Julie Camacho was informed that the gelding not run until the day after passing a stalls test.

The Starter reported that PANAMA CITY broke out of the stalls and was withdrawn at 5:54pm. Tim Easterby was informed that the gelding could not run until the day after passing a stalls test. As it was the second occasion within the previous 12 months that PANAMA CITY had been reported, a further report within the same period would mean the gelding would be prevented from having a stalls test for 6 months.

Following the race, Joanna Mason reported that BROCTUNE AZURE, unplaced, was slowly away.

### **Race 3 - 6:25pm.**

#### **THE LITTLEFAIRS PROPERTY COMPANY HANDICAP STAKES (CLASS 6)**

The Starter reported that REGAL WORLD refused to enter the stalls and was withdrawn at 6:30pm. Tim Easterby was informed that the filly not run until the day after passing a stalls test.

Shortly after leaving the stalls, CATHY'S GIRL (IRE), unplaced, lugged right-handed carrying COPPERLINE (IRE), unplaced, onto KATA HEART'S, unplaced, which was bumped and in turn hampered

ACOUSTIC (IRE), placed fifth. However, after viewing a recording of the incident, it was found that no riding offence was involved.

An enquiry was held to consider the placings in this race after two incidents of interference approaching the final furlong involving the winner DARBUCKS (IRE) ridden by Laura Pearson, COLIGONE KATE, placed second, ridden by Graham Lee, and ROSE'S GIRL, placed fourth, ridden by Ben Curtis. The interference was found to be accidental, as in the first incident, ROSE'S GIRL, edged left-handed before being corrected by its rider, making light contact with COLIGONE KATE (IRE), which became unbalanced as a result. In the second incident a short distance later, ROSE'S GIRL continued to lug left-handed at the same time as DARBUCKS (IRE) edged marginally right-handed, resulting in COLIGONE KATE being briefly tightened for room between the pair. After taking into account that the interference was of a minimal nature and only partially caused by DARBUCKS (IRE), which beat COLIGONE KATE by a neck margin, the Stewards ordered the placings to remain unaltered.

Following the race, P. J. McDonald reported that ACOUSTIC (IRE), placed fifth, fly leapt leaving the stalls. Harrison Shaw reported that MISTER FALSETTO, placed, sixth, ran too free.

#### **Race 4 - 7:00pm.**

##### **THE FIRTH STEELS HANDICAP STAKES (CLASS 5)**

Permission was given for MUTARAAFEQ (IRE) to wear a red hood in the preliminaries and go to post early.

Leaving the stalls, the winner CLEAR ANGEL jumped right-handed moving GREEK KODIAC (IRE), unplaced, into the path of HEADINGLEY (IRE), unplaced, which was hampered. However, after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of CLEAR ANGEL.

Approaching the final half furlong, PERFECT SWISS, which dead heated for fourth place, edged quickly left-handed away from the whip, briefly hampering JACK DANIEL (IRE), unplaced, which in turn caused the rider of SIR MAXI, unplaced, to take a precautionary check. However, after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of PERFECT SWISS.

Following the race, Harrison Shaw reported that JACK DANIEL (IRE), unplaced, hung left-handed in the home straight. Jack Garritty reported that IT JUST TAKES TIME (IRE), unplaced, ran too freely. The Veterinary Officer reported that PERFECT SWISS, which dead heated for fourth, lost its left hind shoe.

#### **Race 5 - 7:35pm.**

##### **THE THIS TIME NEXT YEAR RODDERS FILLIES' HANDICAP STAKES (CLASS 5)**

Permission was given for VINDOBALA (IRE) to go to post early.

Approximately half a furlong out, VINDOBALA (IRE), placed third, hung left giving a slight bump to PERIPETEIA, placed fourth. However, after viewing a recording of the incident, it was found that no riding

offence was involved and that it had not improved the placing of VINDOBALA (IRE).

In the final strides, the winner MY LITTLE QUEENS (IRE) hung quickly right into the path of SAULIRE STAR (IRE). However, after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of MY LITTLE QUEENS (IRE).

Following the race, Paul Mulrennan reported that VINDOBALA (IRE), which started favourite and finished third, ran flat.

**Race 6 - 8:10pm.**

**THE BRIDGE HOTEL & SPA BEST DRESSED FILLIES' HANDICAP STAKES (CLASS 5)**

4 furlongs out, NATALEENA (IRE), placed fourth, switched right to avoid the heels of the rapidly weakening TIGER SPIRIT (IRE), unplaced, and gave a bump to the winner DANNI CALIFORNIA (IRE). However, after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Callum Hutchinson reported that SWISS MISTRESS (IRE), placed sixth, was slowly away. Jason Hart reported that TIGER SPIRIT (IRE), unplaced, was never travelling. The representative of Michael Herrington further reported that the mare may have been unsuited by the Good, Good to Firm in places ground on this occasion and would prefer an easier surface. The Veterinary Officer reported that a post-race examination of the mare failed to reveal any abnormalities.

**Race 7 - 8:40pm.**

**THE IRM SUPPORTS COPPAFEEL! APPRENTICE HANDICAP STAKES (CLASS 6) (Go Racing in Yorkshire Future Stars Apprentice Series)**

On leaving the stalls, TYKENWEAR, unplaced, jumped left crowding MONTICELLO (IRE), placed fourth, onto FANDABIDOZI (IRE), placed sixth. However, after viewing a recording of the incident, it was found that no riding offence was involved.
