### **Race 1 - 1:30pm.**

#### **THE BETUK ALL-WEATHER VASE APPRENTICE HANDICAP STAKES (CLASS 4) (GBBPLUS RACE)**

Following the race, Olivia Tubb reported that WAY OF LIFE, placed fourth, was denied a clear run inside the final furlong and Fred Daly reported that HIGH COURT JUDGE (USA), unplaced, ran too free.

### **Race 2 - 2:05pm.**

#### **THE BETUK ALL-WEATHER VASE MIDDLE DISTANCE HANDICAP STAKES (CLASS 3) (GBBPLUS RACE)**

Permission was given for SILENT AGE (FR), SON OF MAN (IRE), TRIBAL WISDOM (IRE) and ROGUE ENCORE to wear a red hood to post.

An enquiry was held to consider why the signal to mount was given when the recovery vehicle was not in



position and furthermore, a tractor remained working on the track. The Clerk of the Course and the Starter were interviewed. Having heard their evidence, a report was forwarded to the Head Office of the British Horseracing Authority for further consideration.

**Race 3 - 2:40pm.**

**THE BETMGM ALL WEATHER VASE MILE HANDICAP STAKES (CLASS 3)**

Permission was given for BLUE PRINCE (IRE), SOUS LA NEIGE (FR) and LONGLAI (FR) to wear a red hood to post.

Following the race, Trevor Whelan reported that FARASI LANE (IRE), placed sixth, hung left-handed; David Loughnane reported that BRAVO ZULU (IRE), unplaced, ran flat; Finely Marsh reported that BLUE PRINCE (IRE), unplaced, hung right-handed and stopped quickly and Lewis Edmunds reported that LONGLAI (FR), unplaced, reared as the stalls opened resulting in the gelding being slowly away.

**Race 4 - 3:15pm.**

**THE BETUK ALL-WEATHER VASE SPRINT HANDICAP STAKES (CLASS 3)**

Permission was given for MOULIN BOOJ (IRE) to wear a red hood to post; for PRINCE OF PILLO (IRE) to go early to post and for AMAZONIAN DREAM (IRE) to go early and wear a red hood to post.

The Starter reported that AMAZONIAN DREAM (IRE) was unruly in the stalls and was withdrawn at 3:15pm. Rod Millman was informed that the gelding could not run until the day after passing a stalls test.

Inside the final furlong, SILKY WILKIE (IRE), unplaced, drifted right-handed making contact with and turning the hindquarters of PALS BATTALION (IRE), unplaced. After viewing a recording of the incident, it was found that no riding offence was involved.

The performance of CAJETAN which finished tenth of ten, beaten 27 <sup>3</sup>/<sub>4</sub> lengths, was considered. The representative of Jack Channon reported that the gelding was fractious in the stalls and never travelling thereafter. The Veterinary Officer examined CAJETAN post-race during routine testing and had nothing to report.

Following the race, Joe Leavy reported that MUMS TIPPLE (IRE), unplaced, reared as the stalls opened resulting in the gelding being slowly away.

**Race 5 - 3:50pm.**

**THE BETMGM ALL-WEATHER VASE FILLIES' HANDICAP STAKES (CLASS 4)**

Permission was given for LIV MY LIFE (IRE) to be mounted in the chute and for SCATTERING LIGHT (IRE) and MAYO COUNTY to wear a red hood to post.

Following the race, Rhys Elliott reported that DANDY MAGIC (IRE), unplaced, was never travelling and hung left-handed.



**Race 6 - 4:20pm.**

**THE BETUK ALL-WEATHER VASE MARATHON HANDICAP STAKES (CLASS 4) (GBBPLUS RACE)**

Permission was given for ROGUE TORNADO and GALLANT LION to wear a red hood to post.

Following the race, Gina Mangan reported that OPTICIAN, unplaced, hung right-handed.

**Race 7 - 4:50pm.**

**THE BETMGM ALL-WEATHER VASE THREE-YEAR-OLD HANDICAP STAKES (CLASS 4)**

Permission was given for VOCAL LEGEND (IRE) to wear a red hood to post and for THE FLYING SEAGULL (IRE) to wear a red hood to post and be mounted in the chute.

Ollie Sangster was fined £140 for doubly declaring TUCO SALAMANCA (IRE) to run in the THE BETMGM ALL-WEATHER 3 YEAR OLD CHAMPIONSHIPS HANDICAP STAKES at Newcastle and the THE BETMGM ALL-WEATHER VASE THREE-YEAR-OLD HANDICAP STAKES at Lingfield, and the gelding ran in the former.

Following the race, Lewis Edmunds reported that COUL ANGEL (IRE), unplaced, was never travelling.
