THE ENJOY THE RACING APP FOR FREE AMATEUR JOCKEYS' HANDICAP STAKES (CLASS 6)

An enquiry was held to consider interference on the first bend involving LUNA MAGIC, placed second, ridden by Miss Brodie Hampson, the winner, SWISS PRIDE (IRE), ridden By Miss Megan Jordan and SIENNA BREEZE (IRE), unplaced, ridden by Miss Teagan Padgett. Being a 7lb claimer, Padgett was accompanied by a senior jockey. The interference was found to be accidental as LUNA MAGIC switched its leads and shifted slightly left-handed, which caused SWISS PRIDE to be taken slightly off its line resulting in SIENNA BREEZE (IRE) being tightened for room on the rail.

Following the race, Mr Guy Mitchell reported that RABINAL, unplaced, ran too free and Miss Kayla Ruddy reported that ANGEL ON HIGH (IRE), unplaced, was slowly away.

Race 2 - 2:30pm. THE TRY THE RACING APP THIS AFTERNOON NOVICE STAKES (CLASS 5) (GBB RACE)

Permission was given for CYNOSURE (IRE), LUCENTIO (IRE) and OPERATE (IRE) to wear a red hood to post.

Approaching half a furlong out, the winner, CYNOSURE (IRE), shifted left-handed at the same time as OPERATE (IRE), placed second, moved right-handed, which inconvenienced CYNOSURE (IRE) and caused it to be taken slightly off its line, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of CYNOSURE (IRE).





Race 3 - 3:00pm. THE AT THE RACES APP FORM STUDY HANDICAP STAKES (CLASS 6)

Permission was given for JAILBIRD (IRE) to wear a red hood to post.

Following the race, William Carson reported that COMPTON BAY, placed second, hung left-handed.

Race 4 - 3:30pm. THE DOWNLOAD THE RACING APP NOW HANDICAP STAKES (CLASS 4)

Permission was given for PIZ NAIR (IRE) and KINNIGOLI KID (IRE) to wear a red hood to post.

Race 5 - 4:00pm. THE SKY SPORTS RACING SKY 415 / EBF NOVICE STAKES (CLASS 4) (GBB RACE)

Following the race, Neil Callan reported that ROYSDELIGHT (IRE), placed fourth, hung right-handed on the bend.

THE AT THE RACES APP MARKET MOVERS HANDICAP STAKES (CLASS 6)

Permission was given for SUANNI to wear a red hood to post and for HURRICANE ALERT to go to post early.

AUTUMN FLIGHT (IRE), trained by Phil McEntee, had entered the Parade Ring after the signal to mount had been given due to the gelding being difficult to saddle.

Following the race, Josephine Gordon reported that AUTUMN FLIGHT (IRE), placed fourth, ran too free.

Race 7 - 5:00pm.

THE SKY SPORTS RACING HD VIRGIN 519 FILLIES' HANDICAP STAKES (CLASS 5)

Permission was given for SO FARHH SO GOOD (IRE) to be mounted on the chute and for DYNAMISTE to wear a red hood to post.

Following the race, Luke Catton reported that MELERI, unplaced, ran too free; Callum Hutchinson reported that GERT LUSH (IRE), unplaced, never travelled and the Veterinary Officer further reported that GERT LUSH (IRE) lost its left-hind shoe, SHALFA (IRE), unplaced, lost its left-fore shoe and that BELLEPLAINE (IRE), unplaced, finished lame on its left-fore leg.
