<u>Race 1 - 12:15pm.</u> THE DANDARA GOLWG GWENDRAETH MAIDEN HURDLE RACE (CLASS 4) (GBB RACE)

Permission was given for BUCKNA (IRE), HARRY JUNIOR (IRE) and LYLE VIEW (IRE) to all wear a red hood to post.

Race 2 - 12:50pm. THE DIPLOMAT HOTEL CELEBRATING 50 YEARS NOVICES' HANDICAP STEEPLE CHASE (CLASS 5)

Permission was given for CASTING ASPERSIONS (IRE) to wear a hood in the parade ring and for SHILLANAVOGY (IRE) to wear a red hood to post.

An enquiry was held to consider whether Ellis Collier, the rider of HENRY BOX BROWN (IRE), which fell at the last fence, had continued in the race when it was contrary to the horse's welfare. Being a 7lb claiming conditional, Collier was offered the opportunity to be accompanied but declined. The rider was interviewed and shown recordings of the incident and the Veterinary Officer examined the gelding post-race and had nothing to report. Collier explained that having ridden the gelding before, he knew its style of running and was happy with the way his mount travelled into the home straight on the final occasion. He continued that the gelding was running on at the one pace up the home straight, and that he was happy HENRY BOX BROWN (IRE) had sufficient energy to jump the final fence. However he reported that his mount had slipped slightly on take-off, causing the gelding to make a mistake and to fall. The rider's explanation was noted.

Following the race, Noel Williams reported that CASTING ASPERSIONS (IRE), unplaced, made a respiratory noise. The Veterinary Officer reported that MONTYS SOLDIER (IRE), placed second, lost its right-fore shoe.

Race 3 - 1:25pm. THE DIPLOMAT HOTEL AND SPA MAIDEN HURDLE RACE (CLASS 4) (GBB RACE)

Permission was given for ROYAL MALINAS (IRE) to wear a red hood to post.

Following the race, the Veterinary Officer reported that HETTIE HENIGAN, which was pulled up, lost its left-fore shoe.
