THE KINGS COLLEGE TAUNTON NOVICES' HANDICAP HURDLE RACE (CLASS 5)

An enquiry was held to consider interference turning out of the back straight on the final circuit involving KOTARI (FR), placed third, ridden by Freddie Mitchell; BADLANDS BOY (IRE), unplaced, ridden by Theo Gillard; BASMAN PALACE (SAF), unplaced, ridden by Michael Nolan and MINI YEATS (IRE), placed fourth, ridden by Alan Johns. The interference was found to be accidental as BASMAN PALACE (SAF) hung right-handed rounding the bend despite Nolan's efforts to correct the gelding, moving KOTARI (FR) off its intended line onto BADLANDS BOY (IRE). This resulted in Gillard having to take a check, BADLANDS BOY (IRE) stumbling and MINI YEATS (IRE) being crowded for room against the rail.

Following the race, the Veterinary Officer reported that CARD DEALER (IRE), unplaced, was struck into on its left hind.

THE JIM WOODBORNE MEMORIAL JUNIOR 'NATIONAL HUNT' HURDLE RACE (CLASS 4) (GBB RACE)

Following the race, Harry Atkins reported that DENZIL placed second, ran too free.

Race 3 - 1:35pm.

THE JETSET HOLIDAYS NOVICES' HURDLE RACE (CLASS 4) (Novices' Championship Hurdle Series Qualifier) (GBB RACE)

Permission was given for CALI BLACK (IRE) to go early to post; for DON'T TELL ROSIE and TUXEDO JUNCTION to both wear a red hood to the start.

Following the race, Joe Anderson reported that CHEDINGTON'S GUEST, unplaced, hung right-handed and jumped poorly. The Veterinary Officer reported that YOUM JAMEEL (IRE), which was pulled up, and TORRE DEL ORO (IRE), which unseated its rider, had both bled from the nose

Permission was given for HALL LANE (IRE) to wear a red hood to the start.

. THE CLASSIC COLLECTION HOLIDAYS HANDICAP HURDLE RACE (CLASS 3)

Permission was given for KAMAXOS (FR) to go early to post and to be mounted in the chute; for ILANZ (FR) and LIVERPOOL KNIGHT to both wear a red hood to the start.

Following the race, Gearoid Harney reported that GETALEAD (IRE), placed fifth, hung right-handed. The Veterinary Officer reported that ILANZ (FR), placed fourth, finished lame right-fore.

Race 6 - 3:15pm.

THE DAVE CRIDDLE TRAVEL MARES' HANDICAP STEEPLE CHASE (CLASS 5) (Queen Boudicca Mares' Chase Series Qualifier)

An enquiry was held to consider interference on the bend leaving the home straight on the first circuit involving MISS FEDORA, placed third, ridden by Oscar Palmer and MY MATE POLLY, placed second, ridden by Harry Kimber. Being a 7lb conditional, Palmer was accompanied in the enquiry by a senior rider. The interference was found to be accidental as MY MATE POLLY shifted quickly right-handed before being corrected by Kimber, causing MISS FEDORA to become unbalanced against the rail when tightened for room.

Race 7 - 3:50pm.

THE TWIXMAS MEETING 30TH DECEMBER HANDICAP HURDLE RACE (CLASS 5)

Permission was given for BROOMFIELD GALE (IRE) to wear a red hood to the start; for ELUSIVENESS (IRE) to be mounted in the chute.

After an initial false start, the start was effected successfully on the second attempt. However, having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

The Starter reported that there had been a malfunction with the starting tape mechanism, so permission was given for a flag start to be used.
