### **Race 1 - 5:30pm.**

#### **THE SKY SPORTS RACING ON SKY 415 HANDICAP STAKES (CLASS 5)**

The sponsorship in relation to DEVILS ROC, trained by Jonathan Portman, did not comply with the Sponsorship Code of Conduct. Portman was warned as to his responsibility to ensure that the correct sponsorship is carried.

An enquiry was held to consider interference shortly after leaving the stalls involving SONJA HENIE (IRE),

drawn 7, ridden by Thomas Greatrex, TONE THE BARONE, drawn 6, ridden by Silvestre De Sousa and HALLE'S HARBOUR, drawn 5, ridden by Rhian Ingram. Greatrex was cautioned for careless riding for allowing his mount to drift right-handed when insufficiently clear causing interference to TONE THE BARONE, resulting in HALLE'S HARBOUR having to be slightly checked.

Following the race, the Veterinary Officer reported that the winner EYE OF THE WATER (IRE), lost its right fore shoe and Stuart Williams reported that TONE THE BARONE, which started joint favourite and finished eighth, made a noise.

#### **Race 2 - 6:00pm.**

##### **THE BRITISH STALLION STUDS EBF MAIDEN STAKES (CLASS 4) (PLUS 10 RACE)**

ISLAND WARRIOR (IRE) ran keenly to post. Having been checked by the Veterinary Surgeon upon arrival at the start, the colt was deemed fit to race.

Approaching the final furlong, WILFY, unplaced, shifted sharply right-handed causing the rider of FULL SPECTRUM (IRE), unplaced, to have to take a slight check, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Liam Keniry reported that WILFY, unplaced, was slowly away and hung right-handed and Gerald Mosse reported that ERIKA, unplaced, stopped quickly.

#### **Race 3 - 6:30pm.**

##### **THE ODDFELLOWS HANDICAP STAKES (CLASS 4)**

Permission was given for KODIAC EXPRESS (IRE) to go early to post.

#### **Race 4 - 7:00pm.**

##### **THE WINDSOR RACECOURSE FIREWORKS, RETURNS 2ND NOVEMBER HANDICAP STAKES (CLASS 4)**

Permission was given for STATUARIO to wear a hood in the Parade Ring only and the gelding wore earplugs in the preliminaries which were removed at the start.

Approaching the two furlong marker, GLOBAL ART, placed fourth, shifted very marginally right-handed, making slight contact with the winner BLACK LOTUS, which in turn caused interference to PREVENT, unplaced. After viewing a recording of the incident, it was found that no riding offence was involved.

Approaching the one furlong marker, MEDALLA DE ORO, placed fifth, shifted slightly left-handed away from the whip causing the rider of PERFECT REFUGE, placed sixth, to have to take a slight check. After viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of MEDALLA DE ORO.

### **Race 5 - 7:30pm.**

#### **THE RITA ORA LIVE AT WINDSOR RACECOURSE NOVICE STAKES (CLASS 5)**

TORBELLINO, trained by John Best, ran without its left hind shoe as the trainer had not indicated at declaration stage that the filly should be withdrawn in the event of losing a shoe on the way to post.

Approaching the final furlong STAR GUIDE (GER), unplaced, hung right-handed before being corrected back left, causing Jack Mitchell, the rider of CAPLA HUNTRESS, unplaced, to have to take a check. After viewing a recording of the incident, it was found that no riding offence was involved.

Georgia Cox, the rider of SHAUYRA (IRE), placed third, had appeared to stop riding shortly before the winning post. After being interviewed and shown recordings of the incident, Cox was suspended for 10 days for failing to take all reasonable and permissible measures to obtain the best possible placing on a horse that would have finished second.

### **Race 6 - 8:00pm.**

#### **THE SKY SPORTS RACING ON VIRGIN 535 HANDICAP STAKES (CLASS 4)**

Permission was given for TAMMOOZ to wear a hood in the Parade Ring only.
