**Race 1 - 4:40pm.****THE LADBROKES FOOTBALL ACCA BOOSTY NURSERY HANDICAP STAKES (CLASS 6)**

Leaving the stalls JAZZ STYLE (IRE), placed sixth, jumped sharply left-handed at the same time as MR KODI (IRE), placed fourth, jumped right-handed which resulted in RED MAHARANI, placed second, being carried off its intended line and THE WORKS (IRE), placed fifth, and WILLIAM THOMAS (IRE), unplaced, both being tightened for room and losing ground. but after viewing a recording of the incident, it was found that no riding offence was involved, nor had it improved the placing of either JAZZ STYLE (IRE) or MR KODI (IRE).

Following the race, Paul Mulrennan reported that THE WORKS (IRE), placed fifth, reared leaving the stalls and was slowly away.

**Race 2 - 5:10pm**

**THE BETWAY HEED YOUR HUNCH CLASSIFIED STAKES (CLASS 6)**

Permission was given for SAMBUCCA SPIRIT to go to post early.

Leaving the stalls the winner LOULIN jumped left at the same time as SAMBUCCA SPIRIT, placed third, jumped right causing THORNABY PRINCESS, unplaced, and DOLLYWAGGON PIKE, unplaced, to be crowded for room which in turn resulted in SAMBUCCA SPIRIT becoming unbalanced after having its quarters turned but after viewing a recording of the incident, it was found that no riding offence was involved nor had it improved the placing of either LOULIN or SAMBUCCA SPIRIT.

Following the race, Raul Da Silva reported that DOLLYWAGGON PIKE, unplaced, was never travelling and Toby Eley reported that MOCEAD CAPPALL, unplaced, hung left-handed.

**Race 3 - 5:40pm.**

**THE LADBROKES WHERE THE NATION PLAYS NOVICE STAKES (CLASS 5)**

Permission was given for ROYAL CONTEXT (IRE) to go to post early.

The Veterinary Officer reported that ILSERENO, unplaced, had finished lame on its right fore.

**Race 4 - 6:10pm.**

**THE BETWAY SUPPORTING RESPONSIBLE GAMBLING HANDICAP STAKES (CLASS 4)**

Leaving the stalls the winner HAREEM QUEEN (IRE) jumped right carrying ERISSIMUS MAXIMUS (FR), placed fourth onto YOUSINI, placed fifth, which was badly hampered but after viewing a recording of the incident, it was found that no riding offence was involved nor had it improved the placing of HAREEM QUEEN (IRE).

**Race 5 - 6:40pm.**

**THE BETWAY CLASSIFIED STAKES (CLASS 6)**

Permission was given for TADAANY (IRE) to be mounted in the chute and go early to post and for GROUPIE to go early to post.

An enquiry was held to consider interference approaching 1½ furlongs out involving TADAANY (IRE), placed sixth, ridden by Jack Garritty and GROUPIE, placed second, ridden by Andrew Mullen. Garritty was suspended for 3 days for careless riding as he had allowed his mount to shift right-handed without correction when insufficiently clear, causing Mullen to take a significant check.

Seamus Cronin, the rider of HELLOFAGAME, placed third, had appeared to stop riding shortly before the winning post, before being beaten a short head for second place. After being interviewed and shown recordings of the incident and hearing a report from the Veterinary Officer that a post-race examination of the gelding failed to reveal any abnormalities, Cronin was suspended for 10 days for failing to take all reasonable and permissible measures to obtain the best possible placing on a horse that would have

finished second.

#### **Race 6 - 7:10pm.**

##### **THE BOMBARDIER GOLDEN BEER HANDICAP STAKES (CLASS 5)**

Leaving the stalls OLLIVANDER (IRE), placed third, jumped right and carried AL ERAYG (IRE), placed fifth, onto MOXY MARES, placed eighth, which was checked and in turn bumped BOND ANGEL, placed seventh, but after viewing a recording of the incident, it was found that no riding offence was involved nor had it improved the placing of OLLIVANDER (IRE).

Following the race, P.J.McDonald reported that DASHING POET, unplaced, was slowly away and Ben Curtis reported that BOND ANGEL, placed seventh, suffered interference in running.

#### **Race 7 - 7:40pm.**

##### **THE BOMBARDIER "MARCH TO YOUR OWN DRUM" HANDICAP STAKES (CLASS 6)**

Approaching the 3 furlong marker AMBER ROCK (USA), placed third, had to be checked and switched very wide in order to avoid the heels of a rapidly weakening CLOSER THAN CLOSER, unplaced, but after viewing a recording of the incident, it was found that no riding offence was involved.

#### **Race 8 - 8:10pm.**

##### **THE BETWAY LIVE CASINO HANDICAP STAKES (CLASS 6)**

Following the race, Paula Muir reported that BOLD STATEMENT, unplaced, was never travelling and the Veterinary Officer reported that a post-race examination revealed the gelding finished lame on its right-fore.
