was declared void, into the fall of Miss Grace Knowles, who had fallen from GLOBAL STYLE (IRE), passing the half furlong marker with a circuit left to run. Mr Fletcher

Yarham, the rider of FRAVANCO; Mr Jonathan Rees, rider of NATIONAL HEALTH (FR) and Mr Lewis Kent, the rider of MAPOGO were interviewed and shown recordings of the incident. The incident was found to be accidental as FRAVANCO stepped slightly left-handed, moving MAPOGO marginally off its line, resulting in GLOBAL STYLE (IRE) edging left-handed and clipping the heel of NATIONAL HEALTH (FR) and falling.

# THE BEST OF BRITISH EVENTS HANDICAP HURDLE RACE (CLASS 5) (Abandoned)

Permission was given for I LOVE YOU SIVOLA (FR) to be mounted in the chute.

An enquiry was held to consider the circumstances surrounding the deployment of the 'stop race' flag following the fall of Niall Houlihan, the rider of DRUMHELLER (IRE), at the last flight in the back straight, on the first circuit. The Clerk of the Course, the BHA Course Inspector, Caoilin Quinn, the rider of TELLAIRSUE (GER) and James Davies, the rider of ENDERSEN (IRE), were interviewed. The Clerk of the Course explained that the position of the stricken rider after the hurdle meant there was insufficient room for the runners to by-pass safely and therefore, he took the decision to initiate the 'stop race' procedure. The Stewards declared the race void and ordered a report to be forwarded to the Head Office of the British Horseracing Authority.
