#### Race 1 - 5:50pm. THE FLOYDS TURFCARE AND WEEDCARE SOLUTIONS HANDICAP STAKES (CLASS 5)

Following the race, Callum Hutchinson reported that HAVANA SUNSET, placed sixth, was slowly away and William Cox reported that DISEY'S EDGE, placed seventh, hung left-handed.

## Race 2 - 6:20pm. THE PETER VILLARS SPORTSGROUND MAINTENANCE RESTRICTED MAIDEN STAKES (CLASS 5) (for horses





#### in Bands C and D) (GBB RACE)

The Veterinary Officer reported that FOREVER BRIGHT (IRE), trained by David Loughnane appeared to be suffering from ringworm and the trainer did not have a Certificate of Non-Contagiousness. Loughnane was fined £140 and skin scrapings from the horse were sent for analysis.

Approaching the final furlong, the winner, STROZZI (GER), edged slightly left-handed taking ALASKAN WIND (IRE), placed second, slightly off its intended line. Following this, ALASKAN WIND (IRE) edged right-handed despite the best efforts of its rider, taking STROZZI (GER) marginally off its intended line], but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of STROZZI (GER).

Following the race, Shariq Mohd reported that TRUE COMPANY (IRE), unplaced, was slowly away, Richard Kingscote reported that MONKMOOR (IRE), placed sixth, was slowly away, Hector Crouch reported that MYSTICAL MUSIC, placed eighth, ran green and Tom Marquand reported that LARK LANE, placed seventh, hung right-handed.

## Race 3 - 6:50pm. THE FLOYDS TURFCARE HANDICAP STAKES (CLASS 6)

Permission was given for ROSE ALL DAY to go early to post.

An enquiry was held to consider why Laura Young was running POETA BRASILEIRO (IRE) here at Chepstow on going described as Good to Firm, Good in places, having declared the gelding a non-runner at Nottingham on 2 June 2021 on ground with the same official description. The trainer stated that having walked the track here at Chepstow, she felt that the going was easier than described and as a result, she was happy for POETA BRASILEIRO (IRE) to take its chance.

STORM MELODY, trained by Ali Stronge, entered the Parade Ring without its declared cheekpieces, which were then located and fitted to the gelding before going to the start. Stronge was cautioned.

Following the race, Ciaran McKee reported that SHOW ME THE BUBBLY, unplaced, reared as the stalls opened and was slowly away as a result, Luke Morris reported that his saddle has slipped on the winner, SOME NIGHTMARE (IRE) and Edward Greatrex reported that BLUE CABLE, which was pulled up, lost its action; the Veterinary Officer reported that a post-race examination of the gelding failed to reveal any abnormalities other than BLUE CABLE had lost its right-fore shoe.

#### Race 4 - 7:20pm. THE WEE WILLY WUMPKINS EBF RESTRICTED MAIDEN STAKES (CLASS 5) (for horses in Bands C and D) (GBB RACE)





Following the race, David Probert reported that HA'PENNY, placed fourth, was slowly away and ran green, Laura Coughlan reported that RUN RABBIT RUN, unplaced, was slowly away and ran green and Oisin Murphy reported that APPLE GIN, unplaced, stopped quickly; the Veterinary Officer reported that a postrace examination of the filly failed to reveal any abnormalities. Seamus Mullins reported that GENERAL TOM THUMB (IRE), unplaced, was unsuited by the undulations of the track.

### Race 5 - 7:50pm. THE OLLIE FLOYD HANDICAP STAKES (CLASS 5)

WARRANTY (FR) wore earplugs which were removed at the start.

Following the race, Rossa Ryan reported that THEOCRAT (IRE), placed seventh, ran too freely in the early stages and Gina Mangan reported that STORMY NIGHT (GER), unplaced, stopped quickly; the Veterinary Officer reported that a post-race examination found the colt to be stiff behind.

## Race 6 - 8:20pm. THE FINLEY'S DREAM HANDICAP STAKES (CLASS 6)

Permission was given for SISTERANDBROTHER to go early to post.

Following the race, the Veterinary Officer reported that POLAR ICE, placed fourth, lost its left-fore shoe and BEAT THE STORM (IRE), placed fifth, lost its left-fore shoe.

#### Race 7 - 8:50pm. THE NICK RAWLINGS FLOYD'S TURFCARE HANDICAP STAKES (CLASS 6)

An enquiry was held to consider the placings in this race after interference inside the final furlong involving CHIAVARI (IRE), placed second, ridden by Saffie Osborne, SIR CANFORD (IRE), placed third, ridden by Tom Marquand and KING CHARLES (USA), placed fourth, ridden by David Probert. The Stewards considered that the interference had not improved CHIAVARI (IRE)'s placing as SIR CANFORD (IRE), lost little momentum when forced to move off its line and always appeared to be held, both prior to and after the incident. Osborne was suspended for 2 days for careless riding as she allowed her mount to hang right-handed when insufficiently clear of SIR CANFORD (IRE) and KING CHARLES (USA), causing interference to these two runners.

Following the race, Saffie Osborne reported that CHIAVARI (IRE), placed second, hung right-handed and Tom Marquand reported that SIR CANFORD (IRE), placed third, hung left-handed under pressure.
