<u>Race 1 - 4:37pm.</u> THE GERAINT BOWENS WELSH CAP MAIDEN HURDLE RACE (CLASS 4) (DIV I) (GBB RACE)

Following the race, Harry Cobden reported that IT'S A BREEZE (IRE), unplaced, ran too free and the Veterinary Officer reported that DEVON DUDE, placed second, lost its right-fore shoe.

Race 2 - 5:12pm. THE GERAINT BOWENS WELSH CAP MAIDEN HURDLE RACE (CLASS 4) (DIV II) (GBB RACE)

Race 3 - 5:45pm. THE ADEPT GRP CABINETS MARES' HANDICAP HURDLE RACE (CLASS 4)

The performance of GAYE LEGACY (IRE) which was pulled up, was considered. Tom Symonds could offer no explanation for the mare's performance, other than confirming the report from the rider, Caoilin Quinn, that GAYE LEGACY (IRE), was never travelling. The Veterinary Officer examined GAYE LEGACY (IRE), post-race and had nothing to report.

Following the race, the representative of Harry Fry reported that STAR WALKING (IRE), unplaced, made a respiratory noise.

Race 4 - 6:15pm. THE HAPPY RETIREMENT VIV PRIOR HANDICAP STEEPLE CHASE (CLASS 4) (GBB RACE)

Permission was given for A MOMENTS MADNESS (IRE) and SALADAM (FR) to wear a red hood to post.

KARUMA GREY (GER), trained by Alison Thorpe, ran without its declared tongue strap as the trainer had been unable to fit it to the gelding.

Following the race, Robert Dunne reported that SALADAM (FR), which was pulled up, jumped poorly throughout.

Race 5 - 6:45pm. THE ADEPT GRP CABINETS HANDICAP HURDLE RACE (CLASS 3)

Permission was given for EATON ANNE (IRE) to wear a red hood to post.

The winner, BECTIVE ABBEY (IRE), appeared to show improved form compared with its previous run at Ascot on 15 February 2025, where the gelding was pulled up. It was noted that BECTIVE ABBEY (IRE) had undergone wind surgery since its previous run.

Race 6 - 7:15pm. THE LANDOFSMILES HANDICAP STEEPLE CHASE (CLASS 5)

Permission was given for SADLER'S BAY to wear a red hood to post.

Jumping the third last fence, LELANT (IRE), unplaced, jumped sharply left-handed, causing the rider to lose an iron, which caused SHOT BOII (IRE), placed fourth, to be taken off its intended line, but after viewing a recording of the incident, it was found that no riding offence was involved.

The performance of SHOT BOII (IRE) which finished fourth of eleven runners, was considered. David Pipe's representative could offer no explanation for the gelding's performance, other than reporting that the





gelding stopped quickly. The Veterinary Officer examined SHOT BOII (IRE), post-race and had nothing to report.

Following the race, Suzy Smith reported that RECORD HIGH (IRE), which was pulled up, was unsuited by the Soft ground on this occasion, which in her opinion was riding quicker than officially described; Chad Bament reported that BAMPTON STAR, which was pulled up, was never travelling and Daire McConville reported that PERFECT PUPIL (IRE), which was pulled up, jumped and hung right-handed throughout the race.

<u>Race 7 - 7:45pm.</u> THE ADEPT CABINETS HANDICAP HURDLE RACE (CLASS 5)

Permission was given for KYLENOE DANCER to wear a red hood to post.

An enquiry was held to consider interference approaching the final hurdle involving the winner, RODNEY (IRE), ridden by Jack Tudor and KYLENOE DANCER, placed third, ridden by Harry Cobden. The interference was found to be accidental as approaching the final hurdle, RODNEY (IRE), moved quickly away right-handed, away from the wing of the obstacle, causing KYLENOE DANCER to be taken marginally off its intended line.
