Race 1 - 1:30pm.

THE WILLIAM HILL SILVER CUP HANDICAP STAKES (CLASS 2)

Permission was given for DRAWN TO DREAM (IRE) to wear a red hood to post and to be mounted in the chute. LOYAL TOUCH (IRE) wore earplugs which were removed at the start.

Race 2 - 2:05pm.

THE WILLIAM HILL BEVERLEY BULLET SPRINT STAKES (CLASS 1) (Listed Race)

Permission was given for CLARENDON HOUSE to go early to post; DEMOCRACY DILEMMA (IRE) and STAINCLIFF to wear a red hood to post.

Following the race, Ray Dawson reported that CLARENDON HOUSE, unplaced, was slowly away.

Race 3 - 2:35pm.

THE CONSTANT SECURITY HANDICAP STAKES (CLASS 5) (DIV I)

Permission was given for EMERALDS PRIDE to go early to post and SIBYL CHARM (IRE) to wear a red hood to post.

Joanna Mason, the rider of MISS BRAZEN, drawn 7, was slow to remove the blindfold, Mason's

explanation that the blindfold became stuck and took two attempts to remove it was noted.

Approximately 1 furlong out EMERALDS PRIDE, placed fifth, edged quickly right-handed causing the rider of LADY NUNTHORPE (IRE), unplaced, to be crowded for room and have to take a check, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of EMERALDS PRIDE.

Approximately ½ furlong out SOUND REASON, placed second, stepped quickly right-handed causing the rider of TRAVEL CANDY (IRE), unplaced, to have to take a precautionary check, but after viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of SOUND REASON.

Following the race, Duran Fentiman reported that MATTICE, unplaced, was denied a clear run inside the final furlong on several occasions and Brandon Wilkie reported that LET'S GO HUGO (IRE), unplaced, ran too free.

Race 4 - 3:07pm.

THE CONSTANT SECURITY HANDICAP STAKES (CLASS 5) (DIV II)

Permission was given for BELLA KOPELLA (IRE) to go early to post and to be mounted in the chute, TAYGAR to go early to post; CALLIANASSA (IRE) to wear a red hood to post.

An enquiry was held to consider interference inside the final furlong when SOUL SEEKER (IRE), placed third, ridden by David Nolan interfered with WILLOLARUPI (IRE), placed fourth, ridden by Zak Wheatley. Nolan was cautioned for careless riding as he allowed his mount to move slightly left-handed causing Wheatley to take a slight check.

Race 5 - 3:42pm.

Race 6 - 4:20pm.

THE CHURCHILL TYRES MAIDEN STAKES (CLASS 4) (GBB RACE)

Permission was given for AMPHIUS to wear a red hood to post.

Race 7 - 4:55pm.

THE HULL ASPHALT HANDICAP STAKES (CLASS 4)

Permission was given for PARK STREET to go early to post and to be mounted in the chute and ZAPPHIRE (IRE) to go early to post; MONTE LINAS (IRE) to wear a red hood to post. CANCAN IN THE RAIN (IRE) wore earplugs which were removed at the start.

Following the race, Zak Wheatley reported that TOBETSO (IRE), unplaced, was very slowly away and

virtually refused to race and lost considerable distance as a result.

Race 8 - 5:30pm.

THE WESTWOOD APPRENTICE HANDICAP STAKES (CLASS 6)

An enquiry was held to consider interference on the bend into the home straight, involving MR JETMAN (IRE), placed fourth, ridden by Brandon Wilkie and WHATWOULDYOUKNOW (IRE), unplaced, ridden by Ethan Tindall. Being a 7lb claiming apprentice, Tindall was offered the opportunity to be accompanied but declined. Wilkie was suspended for 6 days for careless riding as he shifted his mount right when insufficiently clear causing Tindall to take a considerable check and WHATWOULDYOUKNOW (IRE) to become unbalanced against the rail.

Following the race, Ethan Tindall reported that WHATWOULDYOUKNOW (IRE), unplaced, suffered interference turning into the home straight.
