Race 1 - 2:25pm. THE STAR SPORTS WE BELIEVE IN BOOKMAKING HANDICAP STAKES (CLASS 4)

Permission was given for NIGHT ON EARTH (IRE) to wear a red hood to post.

GRACE ANGEL, trained by Darryll Holland was late in the Parade Ring, due to difficulty saddling the filly.

The performance of NIGHT ON EARTH (IRE) which started favourite and placed fifth, last of the five runners, was considered. Ian Williams' explanation that in his opinion the filly had ran flat having ran only 4 days prior to today's race; the Veterinary Officer examined the filly post-race and had nothing to report.

An enquiry was held following a report from the Veterinary Officer that an Equine Welfare and Integrity Officer had observed a member of Daryll Holland's staff urinating in the stable of GRACE ANGEL following the first race; the Equine Welfare and Integrity Officer and the member of staff were interviewed. After hearing their evidence, Holland was found in breach of Rule (J)20 and fined £140, as being the employing trainer, he is responsible for his employees conduct on course. Holland was reminded to ensure all employees were correctly briefed as to the integrity implications of such behaviour.

Race 2 - 2:55pm. THE DOWNLOAD THE STAR SPORTS APP HANDICAP STAKES (CLASS 6)

ANOTHER JACK (IRE), trained by Karen Jewell, ran the previous day at Chelmsford, finishing eighth of





nine runners. Having been examined by the Veterinary Officer, the gelding was deemed fit to race.

Upon leaving the stalls, BATAL DANDY (IRE), unplaced, jumped right-handed despite the best efforts of its rider to correct the gelding, squeezing EDERGOLE'S GIFT (IRE), placed second, against LITTLE WHITE DOVE (IRE), placed fifth, who was inconvenienced with both runners becoming short of room for a number of strides, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Brandon Wilkie reported that BATAL DANDY (IRE), unplaced, jumped badly righthanded from the stalls; the Veterinary Officer reported that the gelding lost its left-hind shoe, Sean Dylan Bowen reported that EDERGOLE'S GIFT (IRE), placed second, was badly hampered coming out of the stalls and Georgia Dobie reported that LITTLE WHITE DOVE (IRE), placed fifth, was badly hampered leaving the stalls.

Race 3 - 3:25pm. THE STAR SPORTS CLASSIFIED STAKES (CLASS 6)

THE CARLSBERG DANISH PILSNER BRIGHTON MILE CHALLENGE HANDICAP STAKES (CLASS 4) (For the Brighton Mile Challenge Trophy)

Permission was given for both DREAM OF MISCHIEF and OPTIVA STAR (IRE) to wear a red hood to post.

Following the race, Billy Loughnane reported that LUNATICK, placed second, hung left-handed, Joe Leavy reported that OPTIVA STAR (IRE), unplaced, ran too freely, Brandon Wilkie reported that BLENHEIM STAR (IRE), unplaced, ran flat and Sean Dylan Bowen reported that CHARMING WHISPER, placed fourth, was denied a clear run on the run to the line.

Race 5 - 4:25pm. THE STARSPORTS.BET HANDICAP STAKES (CLASS 6)

The performance of CLEAR JUSTICE (IRE) which started favourite and finished last of the six runners, was considered. The representative of Gary & Josh Moore could offer no explanation other than the report from Billy Loughnane that the gelding had ran too freely. CLEAR JUSTICE (IRE) was routine tested.

Race 6 - 4:55pm.

Permission was given for KRACKING to go early to post.
