Race 1 - 6:30pm.**THE BRITISH STALLION STUDS EBF FILLIES' NOVICE STAKES (CLASS 2) (GBB RACE)**

RIVER SEINE (IRE) wore earplugs which were removed at the start.

Race 2 - 7:00pm.**THE CUMBRIA CHAMBER OF COMMERCE HANDICAP STAKES (CLASS 4) (A Jockey Club Grassroots Sprint Series Qualifier)**

Permission was given for POCKLEY to be mounted on the chute.

An enquiry was held to consider interference inside the final furlong involving MOUNTAIN WARRIOR, placed second, ridden by Callum Rodriguez and NELSON GAY (IRE), unplaced, ridden by Sean Kirrane. Rodriguez was cautioned for careless riding as he moved MOUNTAIN WARRIOR (IRE) right-handed when insufficiently clear, taking NELSON GAY (IRE) off its intended line and causing Kirrane to take a slight check.

The performance of MINNESOTA LAD (IRE), which finished unplaced, was considered. The representative of Richard Fahey could offer no explanation for the gelding's performance. The Veterinary Officer examined MINNESOTA LAD (IRE) during routine testing and had nothing to report.

Following the race, Callum Rodriguez reported that MOUNTAIN WARRIOR, placed second, was denied a

clear run inside the final furlong.

Race 3 - 7:30pm.

THE THANK YOU ANNUAL BADGE HOLDERS HANDICAP STAKES (CLASS 4) (A Jockey Club Grassroots Sprint Series Qualifier)

Permission was given for MANIGORDO (USA) to go early to post.

Following the race, Ben Robinson reported that NORTHERN SPIRIT, placed third, was slowly away.

Race 4 - 8:00pm.

THE NOUGHTIES FRIDAY 31ST MAY HANDICAP STAKES (CLASS 4) (A Jockey Club Grassroots Mile Series Qualifier)

Permission was given for JAMES MCHENRY to wear a red hood to post and for FOOLS RUSH IN (IRE) to go early to post and to be mounted on the chute.

Leaving the stalls, REDARNA, placed third, jumped left-handed moving the winner, JAMES MCHENRY, off its intended line, which in turn, caused interference to FOOLS RUSH IN (IRE), placed fourth. After viewing a recording of the incident, it was found that no riding offence was involved and it had not improved the placing of REDARNA.

Race 5 - 8:30pm.

Permission was given for OPERATE (IRE) and PABORUS to wear a red hood to post.

Following the race, Harrison Shaw reported that HIGHLAND OLLY, unplaced, ran green.

Race 6 - 9:00pm.

THE FLAT SEASON PASS AVAILABLE NOW HANDICAP STAKES (CLASS 6)

Permission was given for DUE CONSIDERATION to wear a red hood to post.

Following the race, Callum Rodriguez reported that HARDMAN, unplaced, ran too free; Ben Robinson reported that NORTHERN CRACKSMAN, unplaced, ran too free and Harrison Shaw reported that JESMOND DAWN (IRE), placed third, ran too free.
