a report from the Starter that Rachael Blackmore, the rider of DANCING ON MY OWN (IRE), had not approached the tape at a walk or jig-jog thereby causing a false start. After

being interviewed, Blackmore was suspended for 1 day for misconduct at the start.

Race 1 - 1:20pm.

THE RYANAIR MARES' NOVICES' HURDLE RACE (CLASS 1) (Grade 2) (Registered as THE DAWN RUN MARES' NOVICES' HURDLE) (GBB RACE)

Permission was given for BLUEY (IRE), METKAYINA (IRE), and MYSTICAL GODDESS (IRE) to wear red hoods to post.

After an initial false start, the start was effected successfully on the second attempt from a standing start. However, having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

It was noted that MAUGHREEN (IRE), which finished unplaced, ridden by Mr P W Mullins, whipped round as the start was effected causing the mare to lose many lengths.

Following the race, Tom Bellamy reported that BRENDAS ASKING (IRE), unplaced, hung right-handed throughout. Freddie Gingell reported that JUST A ROSE (FR), which was pulled up, jumped poorly and was never travelling.

Race 2 - 2:00pm.

THE JACK RICHARDS NOVICES' LIMITED HANDICAP STEEPLE CHASE (CLASS 1) (Grade 2) (Registered as The GOLDEN MILLER) (GBB RACE)

Permission was given for FIREFOX (IRE) and WHAT'S UP DARLING (IRE) to wear a red hood to post.

After an initial false start, the start was effected successfully on the second attempt from a standing start. However, having reviewed recordings of the false start, the Starters were satisfied that no riders should be reported for contravening the starting procedures.

Following the race, Sean Bowen reported that MOON D'ORANGE (FR), which was pulled up, made a bad mistake at the water jump; the Veterinary Officer examined the gelding post-race and had nothing to report.

Race 3 - 2:40pm.

THE PERTEMPS NETWORK FINAL HANDICAP HURDLE RACE (CLASS 1) (PREMIER HANDICAP) (GBB RACE)

Permission was given for D ART D ART (FR) to wear a red hood to post, for FEET OF A DANCER (FR) to wear a hood in the Parade Ring, and for ONE BIG BANG (IRE) to wear a red hood and go early to post.

Turning into the home straight, MAXI MAC GOLD (FR), unplaced, stepped quickly left-handed before being corrected resulting in SUPREME GIFT (IRE), unplaced, becoming momentarily short for room, but





after viewing a recording of the incident it was found that no riding offence was involved.

The performance of WIN SOME LOSE SOME (IRE), which finished unplaced, was considered. It was noted that the representative of Padraig Roche could offer no explanation for the gelding's performance; the Veterinary Officer examined WIN SOME LOSE SOME (IRE) post-race during routine testing and had nothing to report.

Following the race, Alan King reported that HARBOUR LAKE (IRE), which was pulled up, had bled from the nose.

Race 4 - 3:20pm.

THE RYANAIR STEEPLE CHASE (CLASS 1) (Registered as The FESTIVAL TROPHY) (Grade 1) (GBB RACE)

Permission was given for ENVOI ALLEN (FR) to wear a red hood to post.

The performance of IL EST FRANCAIS (FR), which started second favourite and finished sixth of seven finishers, was considered. The representative of Noel George and Amanda Zetterholme confirmed James Reveley's report that the gelding stopped quickly, and further added that IL EST FRANCAIS (FR) was unsuited by Cheltenham and would prefer a flatter track; the Veterinary Officer examined the gelding post-race and had nothing to report.

The performance of DJELO (FR), which finished seventh, beaten by 65 lengths, was considered. It was noted that Charlie Deutsch reported that the gelding was outpaced, but that Venetia Williams could offer no further explanation for DJELO (FR)'s performance; the Veterinary Officer examined DJELO (FR) post-race and had nothing to report.

Race 5 - 4:00pm.

THE PADDY POWER STAYERS' HURDLE RACE (CLASS 1) (Grade 1) (GBB RACE)

Permission was given for FRANCISCAN ROCK (IRE) and THE WALLPARK (IRE) to wear a red hood to post, and for GA LAW (FR) to wear a red hood, go early to post, and be mounted in the chute.

CRAMBO fell at the final flight with a circuit to go causing HOME BY THE LEE (IRE) to unseat its rider, and further causing THE WALLPARK (IRE), placed third, and GA LAW (FR), which was subsequently pulled up, to become inconvenienced.

Race 6 - 4:40pm.

THE TRUSTATRADER PLATE HANDICAP STEEPLE CHASE (CLASS 1) (PREMIER HANDICAP) (GBB RACE)

Permission was given for TAHMURAS (FR) to wear a red hood to post, and for IL RIDOTO (FR) to wear a red hood, go early to post, and be mounted in the chute.

The Starter reported that Mr Robert James, the rider of CONFLATED, had not approached the tape at a walk or jig-jog, thereby causing a false start. After being interviewed, Mr James was suspended for 2 days for misconduct at the start, this being his second offence within the previous 12 months. Being a 7lb





claimer, Mr James was offered the opportunity to be accompanied in the enquiry but declined.

Following the race, Mr Robert James reported that CONFLATED (IRE), placed eighth, made a bad mistake at the second last fence, Freddie Gingell reported that IL RIDOTO (FR), unplaced, ran too free, and Ben Jones reported that PERSONAL AMBITION (IRE), which was pulled up, jumped poorly.

Race 7 - 5:20pm.

THE FULKE WALWYN KIM MUIR CHALLENGE CUP AMATEUR JOCKEYS' HANDICAP STEEPLE CHASE (CLASS 2) (SPONSORED BY THAMES MATERIALS) (GBB RACE)

Permission was given for GIT MAKER (FR) and WESTERINTHEPARK (IRE) to wear a red hood to post.

SA MAJESTE (FR) and NINE GRACES both made contact with the plastic running rail in the chute whilst proceeding to the course. Having been checked by the Veterinary Surgeon upon arrival at the start, both were deemed fit to race.

SINE NOMINE was kicked by another runner at the start, having been checked by the Veterinary Surgeon, the mare was deemed fit to race.

The Starter reported that Mr William Biddick, the rider of GIT MAKER (FR), had disobeyed the Starter's Instruction to continue proceeding towards the start with the rest of the field. The rider and the Starter were interviewed and recordings of the incident were shown. Mr Biddick was suspended for 1 day for failing to comply with the Starting Procedures Code.

Having turned down the hill after the fourth last fence in a tightly packed field, there was interference between MIDNIGHT OUR FRED (IRE), which was subsequently pulled up, WALKING ON AIR (IRE), unplaced, CLEATUS POOLAW, which was subsequently pulled up, and NINE GRACES, unplaced, which resulted in WALKING ON AIR (IRE) and CLEATUS POOLAW becoming short of room and unbalanced. Having viewed a recording of the incident it was found that no riding offence was involved.

Following the race, Mr Jack Hendrick reported that FANTASTIC LADY (FR), which was pulled up, stopped quickly; the Veterinary Officer examined the mare post-race and had nothing to report. Miss Olive Nicholls reported that GELINO BELLO (FR), which was pulled up, was never travelling, the Veterinary Officer reported that GIT MAKER (FR), unplaced, finished lame on its right-fore leg, Mr N McParlan reported that MIDNIGHT OUR FRED (IRE), which was pulled up, was never travelling, Mr Stephen Connor reported that NOW WHERE OR WHEN (IRE), which was pulled up, was never travelling.
