# THE UNIBET SUPPORTS SAFER GAMBLING FILLIES' HANDICAP STAKES (CLASS 4) (London Sprint Series Qualifier)

Permission was given for SHALLOW and MY AWELE (IRE) to wear a red hood to post.

Following the race, William Carson reported that CINQUE VERDE, placed third, anticipated the start and was slowly away as a result.

#### Race 2 - 2:30pm. THE UNIBET ZERO% MISSION MAIDEN FILLIES' STAKES (CLASS 5) (GBB RACE)

Permission was given for LA TRINITE to wear a red hood to post.

# Race 3 - 3:05pm.

# THE racingtv.com HANDICAP STAKES (CLASS 6)

The Starter reported that SOLD THE DREAM refused to enter the stalls and was withdrawn at 3:09pm. Michael Madgwick was informed that the gelding could not run until the day after passing a stalls test.

Following the race Tyler Heard reported that HEERATHETRACK, placed third, anticipated the start and was slowly away as a result.

#### Race 4 - 3:40pm. THE ADDITIONAL NOVICE STAKES (CLASS 5)

Permission was given for ALMOSH'HER to go early to post.

Following the race, Connor Planas reported that COURAGEOUS GOLD (IRE), unplaced, hung left-handed throughout.

## Race 5 - 4:15pm. THE FREE BET WITH UNIBET'S BETBUILDER REBOUND HANDICAP STAKES (CLASS 6) (DIV I)

Permission was given for DREAM BY DAY to go early to post, for EL HIBRI (IRE) to wear a red hood to post, and for SAVANNAH SMILES (IRE) to go early to post wearing a red hood.

An enquiry was held to consider interference approaching the first bend when EL HIBRI (IRE), placed second, ridden by Ryan Kavanagh interfered with PRINCE OF BEL LIR (IRE), placed third, ridden by David Probert. Marco Ghiani, the rider of the winner, BRUNEL CHARM, was also present but was found not to be involved. Kavanagh was cautioned for careless riding as he allowed his mount to drift right-handed when insufficiently clear, causing Probert to take a check.





#### <u>Race 6 - 4:45pm.</u> THE FREE BET WITH UNIBET'S BETBUILDER REBOUND HANDICAP STAKES (CLASS 6) (DIV II)

An enquiry was held to consider interference approaching the final furlong involving the winner, COURT DRIVE (IRE), ridden by Hayley Turner, MIGHTY GURKHA (IRE), placed third, ridden by Robert Havlin and ALSHIMALI (IRE), placed fifth, ridden by William Carson. Turner was suspended for 2 days for careless riding as, at the same time as MIGHTY GURKHA (IRE) shifted marginally left-handed, she allowed her mount to drift right-handed when insufficiently clear, resulting in Carson having to take a check.

Following the race, Marco Ghiani reported that MOND (GER), unplaced, was slowly away.

#### <u>Race 7 - 5:15pm.</u> THE UNIBET MORE EXTRA PLACE RACES (LONDON SPRINT SERIES QUAL) HANDICAP STAKES (CLASS 5) (DIV I)

An enquiry was held to consider interference on the first bend when the winner, DISTANT RUMBLE, ridden by George Bass interfered with BERNING HOT (IRE), unplaced, ridden by William Carson. Tom Queally, the rider of RAGE OF THUNDER (IRE), placed third, was also present but was found not to be involved. The interference was found to be accidental as a free and green running DISTANT RUMBLE drifted off the rail before edging back, causing BERNING HOT (IRE) who had improved up the inside, to be checked.

## Race 8 - 5:45pm.

## THE UNIBET MORE EXTRA PLACE RACES (LONDON SPRINT SERIES QUAL) HANDICAP STAKES (CLASS 5) (DIV II)

Permission was given for FORO ROMANO (IRE) and COMMENDATION to wear a red hood to post.

An enquiry was held to consider interference approximately 1 ½ furlongs out when COSMIC FORCE, placed third, ridden by Billy Loughnane interfered with MIAKODA (IRE), unplaced, ridden by Darragh Keenan and PIRANHA RAMA, unplaced, ridden by Jordan Williams. Loughnane was suspended for 2 days for careless riding as he angled for a gap with insufficient room giving a bump to MIAKODA (IRE) and subsequently a minor bump to PIRANHA RAMA.

Following the race, Marco Ghiani reported that FORO ROMANO (IRE), placed second, ran too free, and Billy Loughnane reported that COSMIC FORCE, placed third, was slowly away and hung left-handed under pressure.

## Race 9 - 6:15pm. THE TRY UNIBET'S NEW SMARTVIEW RACECARDS HANDICAP STAKES (CLASS 5)

Permission was given for KING OF ITHACA to wear a red hood to post.

Following the race, Darragh Keenan reported that PORT ROAD (USA), unplaced, was denied a clear run





1 furlong out, and Callum Shepherd reported that G'DAAY, unplaced, hung left-handed under pressure.
