## THE DARLEY EBF NOVICE STAKES (CLASS 2) (GBB/GBBPLUS RACE)

Permission was given for CALIBAN (IRE) and EMERALD ISLAND (FR) to wear a red hood to post.

#### Race 2 - 2:00pm.

#### THE FREE BET WITH UNIBET BETBUILDER REBOUND HANDICAP STAKES (CLASS 4) (DIV I) (GBBPLUS RACE)

Permission was given for WOODSTOCK CITY to wear a red hood to post and for SALAMANCA CITY (IRE) to be mounted on the course and wear a red hood to post.

Approximately one furlong out, Rhys Elliott the rider of POL ROGER (IRE), placed fifth, struck YOKOHAMA (IRE), placed second, across the nose with his whip, but after viewing a recording of the incident, it was considered to be accidental.

#### Race 3 - 2:40pm.

#### THE TRY UNIBET'S NEW SAME RACE MULTIS HANDICAP STAKES (CLASS 2)

Permission was given for YORKSHIRE (IRE) to go to post early wearing a red hood.

Following the race, Tom Marquand reported that ENGLISH OAK, unplaced, was slowly away.

#### Race 4 - 3:15pm.

## THE FREE BET WITH UNIBET BETBUILDER REBOUND HANDICAP STAKES (CLASS 4) (DIV II) (GBBPLUS RACE)

Permission was given for NIGHT BREEZE (IRE), AZAHARA PALACE, AFLOAT and GISELLES





DEFENCE (IRE) to wear a red hood to post.

## Race 5 - 3:50pm.

#### THE READ RICHARD HANNON WEEKLY UNIBET BLOG HANDICAP STAKES (CLASS 5)

Permission was given for ARNAZ and ASINARA to wear a red hood to post and for VAUNTED to be mounted on the course and to go to post early and for PAPA COCKTAIL (IRE) to go to post early.

Following the race, Jason Watson reported that ASINARA, placed third, hung right-handed and the Veterinary Officer reported that CALL TIME (IRE), unplaced, lost its left-fore shoe.

### Race 6 - 4:25pm.

#### THE UNIBET MORE EXTRA PLACE RACES HANDICAP STAKES (CLASS 5)

Permission was given for LORD CAPULET (IRE) to go to post early, for FEAR AND FAST to wear a red hood to post and for BUST A MOON to go to post early wearing a red hood.

The Starter reported POWER OF TWINS was the subject of a third criteria failure. Richard Hannon was informed that the filly could not run until the day after passing a stalls test.

SOLAR BIRICZ (IRE) was withdrawn due to an equipment failure when the bridle broke in the stalls. The reins were inspected and as they were found to be in a serviceable condition and the failure could not have been predicted, no further action was taken.

Just inside two furlongs out, GESUNDHEIT, unplaced, shifted right-handed, resulting in POWER OF TWINS, unplaced, to be moved off its intended line, which in turn caused the rider of LAURENS DREAM, unplaced, to take a check momentarily having been crowded for room against the rail, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Joanna Mason reported that LAURENS DREAM, unplaced, suffered interference, just inside the final two furlongs; Rhys Elliott reported that ROSE OF NEW JERSEY, unplaced, was denied a clear run approximately two furlongs out; Robert Havlin reported that LORD CAPULET (IRE), unplaced, stopped quickly; The Veterinary Officer examined LORD CAPULET (IRE), during routine testing and had nothing to report and Silvestre De Sousa reported that GESUNDHEIT, unplaced, stopped quickly. The Veterinary Officer examined GESUNDHEIT, post-race and had nothing to report.

#### Race 7 - 4:55pm.

#### THE TRY UNIBET NEW SMARTVIEW RACECARDS EBF FILLIES' NOVICE STAKES (CLASS 4) (GBB RACE)

Permission was given for BETTY BASSETT (IRE) and SILVER CHAMBER to wear a red hood to post.

Race 8 - 5:25pm.

THE GET BEST ODDS GUARANTEED AT UNIBET HANDICAP STAKES (CLASS 4)





Permission was given for YABHER and BOSTON RUN (IRE) to wear a red hood to post.

On the bend leaving the back straight, HIGH ON HOPE, placed third, became awkwardly placed on the heels of IMPERIAL TROOPER (IRE), unplaced, which resulted in the gelding appearing to clip a heel and stumble, but after viewing a recording of the incident, it was found that no riding offence was involved.

The Stewards noted, that on the bend leaving the back straight, WELL ENOUGH (IRE), unplaced, appeared to stumble and become unbalanced.
