Race 1 - 1:20pm. THE CASUMO PROUD TO SUPPORT BRITISH RACING HANDICAP STAKES (CLASS 3)

Permission was given for SIDE SHOT to wear a red hood in the preliminaries which was removed at the start.

Following the race, the Veterinary Officer reported that SIDE SHOT, placed fourth, had lost its right hind shoe.

Race 2 - 1:55pm





THE CASUMO HORSE RACING AND SPORTS BETTING HANDICAP STAKES (CLASS 3)

Permission was given for RAATEA to be mounted on the course and go to post early.

Approaching the first bend, the free running RAATEA, unplaced, had to take back off the heels of SUNSET BREEZE, unplaced. However, viewing a recording of the incident it was found that no riding offence was involved.

Inside the final furlong there was interference between STONE SOLDIER (IRE), placed third, which edged right at the same time as the winner, MOLLS MEMORY, lugged left, causing the pair to bump each other momentarily. However after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, the representative of Sir Mark Prescott reported that SUNSET BREEZE, unplaced, was unsuited by the Heavy ground on this occasion and would prefer a sounder surface. Julie Camacho reported that RAATEA, unplaced, was unsuited by the Heavy ground on this occasion and would prefer a sounder surface.

<u>Race 3 - 2:25pm.</u> THE DOWNLOAD THE CASUMO APP TODAY HANDICAP STAKES (CLASS 2)

An enquiry was held to consider interference 3½ furlongs out when FUTURE INVESTMENT, unplaced, ridden by Oisin Murphy, interfered with POSTILEO (IRE), placed fourth, ridden by David Egan. Murphy was suspended for 2 days for careless riding as he had switched left-handed when not sufficiently clear, taking POSTILEO off his intended line.

Following the race, Paul Mulrennan reported that HIROSHIMA, unplaced, hung left in the home straight. The Veterinary Officer reported that POSTILEO (IRE), placed fourth, had lost its right hind shoe.

<u>Race 4 - 3:00pm.</u> THE JOIN CASUMO TODAY SILVER BOWL HANDICAP STAKES (CLASS 2)

Permission was given for DARK LION (IRE) to go to post early.

The performance of HEADINGLEY (IRE), which finished unplaced, was considered. The representative of Mark Johnston could offer no explanation for the colt's performance. The Veterinary Officer reported that a post-race examination of the colt during routine testing failed to reveal any abnormalities.

Following the race, Paddy Mathers reported that SEASETT, placed second, was denied a clear run approaching 2 furlongs out. Oisin Murphy reported that NEBULOSA, unplaced, weakened quickly in the testing conditions; the Veterinary Officer reported that a post-race examination of the filly failed to reveal any abnormalities.

Race 5 - 3:35pm





THE CASUMO BET10GET10 SANDY LANE STAKES (CLASS 1) (Group 2)

An enquiry was held to consider interference 1½ furlongs out when UMM KULTHUM (IRE), placed third, ridden by Paul Hanagan, interfered with MUJBAR, unplaced, ridden by Dane O'Neill. The interference was found to be accidental as having committed for a legitimate gap, that gap had then narrowed due to horses shifting left from Hanagan's outside.

An enquiry was held to consider interference again 1½ furlongs out when the winner, ROHAAN (IRE) ridden by Shane Kelly, had interfered with LIGHT REFRAIN, placed fourth, ridden by Tom Marquand. Kelly was cautioned for careless riding as he had edged left moving LIGHT REFRAIN marginally off its intended line.

Adam McNamara, the rider of DRAGON SYMBOL, placed second, was suspended for 2 days for using his whip above the permitted level from 1³/₄ furlongs out.

Following the race, the representative of Michael Bell reported that THE LIR JET (IRE), unplaced, was unsuited by the Heavy ground on this occasion and would prefer a sounder surface.

Race 6 - 4:10pm.

THE CASUMO BEST ODDS GUARANTEED TEMPLE STAKES (CLASS 1) (Group 2)

Following the race, the Veterinary Officer reported that JABBAROCKIE, placed sixth, finished lame right fore.

Race 7 - 4:45pm. THE CASUMO PROUD SPONSORS OF READING FC HANDICAP STAKES (CLASS 4)

Permission was given for TWO COP BOP to go to post early.

Following the race, David Loughnane reported that TRUMBLE (IRE), unplaced, was unsuited by the Heavy ground on this occasion and would prefer a sounder surface.
