THE ZYN PARTNER OF THE JOCKEY CLUB NURSERY HANDICAP STAKES (CLASS 3)

Permission was given for SILENT APPLAUSE (IRE) to wear a red hood to the start.

Race 2 - 6:15pm.

THE VISIT racingtv.com AMATEUR JOCKEYS' HANDICAP STAKES (CLASS 5) (A Jockey Club Grassroots Stayers Series Qualifier)

The Clerk of the Scales objected to FAST FRED, unplaced, ridden by Miss Pippa Brown, and trained by Phillip Makin on the grounds of the rider weighing in at 9 stone 10 lbs having weighed out at 10 stone 10½ lbs. The rider, the trainer and the Clerk of the Scales were interviewed. Having reviewed video recordings of the incident, the Stewards were satisfied that the weight discrepancy was due to the weight cloth falling off approximately 1 furlong out. FAST FRED was disqualified.

Race 3 - 6:50pm.**THE KINGDOM GROUP SERVICES EBF MAIDEN STAKES (CLASS 3) (GBB/GBBPLUS RACE)**

Race 4 - 7:25pm.**THE SOCK SHOP EBF RESTRICTED NOVICE STAKES (CLASS 3) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (GBB RACE)**

Permission was given for WHAT'S THE PLAN to wear a red hood to the start.

The Starter reported that RED SPELLS DANGER (IRE) was unruly in the stalls and withdrawn at 7:26pm. Tim Easterby was informed that the gelding could not run until the day after passing a stalls test.

Following the race, Jonny Peate reported that RISK AVERSE REBEL (IRE), unplaced, was slowly away.

Race 5 - 8:00pm.**THE HERITAGE TRADE FRAMES EBF RESTRICTED MAIDEN FILLIES' STAKES (CLASS 3) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (GBB RACE)**

Permission was given for MOONSHINE (IRE) to wear a red hood to the start.

An enquiry was held to consider interference approaching 1 furlong out involving TRUST AMY (IRE), placed fourth, ridden by Jonny Peate, and COCKTAIL LOUNGE (IRE), unplaced, ridden by Kaiya Fraser. Peate was suspended for 2 days for careless riding as he failed to take sufficient steps to prevent his horse from shifting right-handed resulting in Fraser having to take a check on COCKTAIL LOUNGE (IRE).

Race 6 - 8:30pm.**THE OAKMERE HOMES HANDICAP STAKES (CLASS 5)**

Permission was given for FINBAR'S LAD to wear a red hood to the start and for RASCAL RECKNELL (FR) to go early to post wearing a red hood.

JOE MASSERIA (IRE) made contact with the plastic railing in the chute. Having been checked by the Veterinary Surgeon at the start, the gelding was deemed fit to race.

The performance of STRATOCRACY (IRE), which started favourite and finished unplaced, beaten by 8¼ lengths, was considered. It was noted that Kevin Frost could offer no explanation for the gelding's performance on this occasion and the Veterinary Officer examined STRATOCRACY (IRE) post-race and had nothing to report.

Following the race, Daniel Muscutt reported that CHIFA (IRE), unplaced, hung left-handed.
