Permission was given for TOP OF THE BAY (IRE) to be mounted on the course.

The performance of TOP OF THE BAY (IRE), which started favourite and finished last of the nine finishers, beaten by 45% lengths, was considered. The representative of Sam England's explanation that the gelding had boiled over in the preliminaries was noted and the Veterinary Officer examined TOP OF THE BAY (IRE) post-race and had nothing to report.

# THE HARRY DOUGLAS ESTATE AGENCY HANDICAP STEEPLE CHASE (CLASS 5)

The performance of SUPER CITIZEN, which finished last of the eight finishers, beaten by 85½ lengths, was considered. The representative of Lucinda Hughes' explanation that the gelding was unsuited by the Going, which was officially described as Good to Soft, Good in places on this occasion and in their opinion was riding slower than described, and SUPER CITIZEN would prefer a faster surface was noted. The Veterinary Officer examined the gelding post-race during routine testing and had nothing to report.
