Race 1 - 1:40pm. THE 'RASEN ROCKS' ON SATURDAY 17th AUGUST CONDITIONAL JOCKEYS' NOVICES' LIMITED HANDICAP HURDLE RACE (CLASS 5)

Following the race, Joe Anderson reported that MOUNT FERNS (IRE), unplaced, became tight for room inside the final furlong.

Race 2 - 2:10pm. THE PAW PATROL GUEST APPEARANCE 7TH JULY MAIDEN HURDLE RACE (CLASS 4) (GBB RACE)

Permission was given for RED NILE (IRE) to be mounted in the chute.





Following the race, Mike Sowersby reported that LORD WARBURTON (IRE), unplaced, made a respiratory noise.

Race 3 - 2:40pm. THE JEFF FLEET MEMORIAL HANDICAP STEEPLE CHASE (CLASS 5)

Sam England was fined £140 for doubly declaring CROAGH PATRICK (IRE) to run in THE JEFF FLEET MEMORIAL HANDICAP STEEPLE CHASE (CLASS 5) at Market Rasen and THE AK BETS BIG PRICES BIG LIMITS HANDICAP STEEPLE CHASE (CLASS 4) at Sedgefield and the gelding ran in the latter.

Following the race, Dylan Johnston reported that OKAVANGO DELTA (IRE), which was pulled up, stopped quickly; the Veterinary Officer examined the gelding post-race and had nothing to report and Charlie Hammond reported that HARRY DU BERLAIS (IRE), which was pulled up, jumped left-handed.

Race 4 - 3:15pm. THE VICTOR LUCAS MEMORIAL HANDICAP HURDLE RACE (CLASS 3)

Permission was given for SHANTOU EXPRESS (IRE) to wear a red hood to post and for GIOVANNI CHANGE (FR) to be led in at the start.

Following the race, David Bass reported that SHANTOU EXPRESS (IRE), which was pulled up, stopped quickly; the Veterinary Officer examined the gelding post-race and had nothing to report and Harry Cobden reported that LEGIONAR (GER), which was pulled up, stopped quickly; the Veterinary Officer examined the gelding post-race and had nothing to report

Race 5 - 3:50pm. THE LUCAS MACHINERY HANDICAP STEEPLE CHASE (CLASS 3) (Abandoned)

An enquiry was held to consider the circumstances surrounding the deployment of the 'stop race' flag following an injury to a runner just past the winning post on the first circuit. The Clerk of the Course, Racecourse Executive and Veterinary Officer were interviewed. The Clerk of the Course explained that after a runner was injured on the first circuit there was insufficient room for the runners to pass safely, the decision was made in conjunction with the Head Groundsman to initiate the 'stop race' procedure and deploy the 'stop race' flag. The Stewards declared the race void.

Race 6 - 4:25pm. THE BOOK SUMMER PLATE LADIES DAY NOW HANDICAP HURDLE RACE (CLASS 5) (DIV I)

Permission was given for BLACK LIGHTNING (IRE) to wear a red hood to post.

Following the race, Luke Scott reported that GET A SUPERSTAR (IRE), placed fourth, was denied a clear run approaching the second last flight of hurdles.
