### **Race 1 - 4:23pm.**

**THE FREE TIPS DAILY ON attheraces.com AMATEUR JOCKEYS' HANDICAP STAKES (CLASS 5)**

Permission was given for both YEOMAN and SOPHOSC (IRE) to wear red hoods to post.

Miss Brodie Hampson, the rider of ALAZWAR (IRE), drawn 11, had appeared not to keep straight from the stalls. After being interviewed and shown recordings of the incident, the rider was suspended for 1 day on dates to be notified to her by the Head Office of the British Horseracing Authority.

### **Race 2 - 4:55pm.**

**THE AT THE RACES APP FORM STUDY NURSERY HANDICAP STAKES (CLASS 5)**

Permission was given for WOODHAY WHISPER (IRE) to wear a red hood to post.

Leaving the stalls, GHOSTMAN, placed fourth, jumped right-handed bumping TOOLATETONEGOTIATE,

placed second, which was hampered when moved onto the heels of KODIBEAT, unplaced, but after viewing a recording of the incident, it was found that no riding offence was involved.

Entering the bend leaving the back straight OVER SPICED, unplaced, threw its head in the air when racing ungenerously and lost its position between GHOSTMAN, placed fourth, and WOODHAY WHISPER (IRE), placed fifth, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Raul Da Silva reported that SON OF WIND (IRE), unplaced, had no more to give.

#### **Race 3 - 5:30pm.**

**THE GET RACEDAY READY APP EBF "CONFINED" NOVICE STAKES (CLASS 5) (for horses which have run no more than twice) (GBB RACE)**

Leaving the stalls, ALTHANEYAH (IRE), unplaced, jumped slightly right-handed inconveniencing RIYADH GEM (IRE), unplaced, which had already been slowly into stride, but after viewing a recording of the incident, it was found that no riding offence was involved.

Following the race, Harrison Shaw reported that COOLS GOLD, unplaced, never travelled.

#### **Race 4 - 6:00pm.**

**THE AT THE RACES APP MARKET MOVERS "CONFINED" FILLIES' NOVICE STAKES (CLASS 5) (no more than three runs) (DIV I) (GBB RACE)**

Permission was given for GOODNIGHT IRENE (IRE) to wear a red hood to post.

Following the race, Cieren Fallon the rider of BLUE SECRET, placed third, reported that he lost his left iron for a short distance leaving the stalls; Hollie Doyle reported that QUEEN OF THE ROSES (IRE), unplaced, hung badly left-handed, causing the bit to slip through the horse's mouth. The Veterinary Officer examined QUEEN OF THE ROSES post-race and had nothing to report; Sean Levey reported that KEBILI, unplaced, never travelled and the filly appeared reluctant to stretch out; the Veterinary Officer examined KEBILI post-race and had nothing to report; Georgia Dobie reported that CHAMPAGNEBREAKFAST, unplaced, clipped heels and stumbled shortly after leaving the stalls.

#### **Race 5 - 6:30pm.**

**THE AT THE RACES APP MARKET MOVERS "CONFINED" FILLIES' NOVICE STAKES (CLASS 5) (no more than three runs) (DIV II) (GBB RACE)**

An enquiry was held to consider interference rounding the first bend involving, STAR CAST, unplaced, ridden by Luke Morris, HELSTON DANCE, unplaced, ridden by Rhys Clutterbuck and TAKE A BREATH, placed third, ridden by Cieren Fallon. Fallon was suspended for 2 days for careless riding as he had angled his mount left-handed in behind the leaders without being fully clear of STAR CAST causing Morris to take a check, which in turn tightened HELSTON DANCE for room on the rail.

Following the race the Veterinary Officer reported that MOTABA AH (IRE), unplaced, lost its right-fore shoe;

**Race 6 - 7:00pm.**

**THE SKY SPORTS RACING HD VIRGIN 519 HANDICAP STAKES (CLASS 6)**

Permission was given for SAFFREDI to go early to post wearing a red hood; for SEA THE BUCKTHORN to go early to post.

Shortly after the start, SAFFREDI, placed fifth, lugged right-handed moving BEAR TO DREAM (IRE), unplaced, onto TILL IT SHINES (IRE), placed third, which received a bump and was shifted into the path of SEA THE BUCKTHORN, unplaced, causing its rider to take a check and in turn slightly impede the winner SPLIT ELEVENS, but after viewing a recording of the incident, it was found that no riding offence was involved.

An enquiry was held to consider interference rounding the home bend involving BOSSY PARKER (IRE), placed fourth, ridden by Andrew Elliott and A PINT OF BEAR (IRE), placed second, ridden by Luke Morris. Morris was cautioned for careless riding as he edged his mount right-handed off the rail when insufficiently clear of BOSSY PARKER (IRE), causing Elliott to briefly take a check.

Passing the 1 furlong marker, SAFFREDI, placed fifth, hung right-handed before being corrected by its rider moving A PINT OF BEAR (IRE), placed second, off its intended line, but after viewing a recording of the incident, it was found that no riding offence was involved.

The performance of SHAMARDIA which finished unplaced, beaten by 15½ lengths, was considered. Ismail Mohammed's explanation that the filly was unsuited by being trapped 3 wide without cover from stall 12, on this occasion was noted. The Veterinary Officer examined SHAMARDIA post-race and had nothing to report.

Following the race, Jack Doughty reported that STELLA HOGAN (IRE), unplaced, was slowly away; Andrew Elliott reported that BOSSY PARKER (IRE), placed fourth, hung left-handed.

**Race 7 - 7:30pm.**

**THE FREE DIGITAL RACECARD AT [raceday-ready.com](https://www.raceday-ready.com) HANDICAP STAKES (CLASS 4)**

The winner, HAKU (IRE), appeared to show improved form compared with its previous run at Kempton on 7th September 2024, where the gelding finished ninth of ten runners, beaten by 12 lengths. It was noted that Mark Loughnane could offer no explanation for the improved form of HAKU (IRE) other than the gelding performs well at Wolverhampton. HAKU (IRE) was routine tested.

Following the race, the Veterinary Officer reported that FEARLESS BAY (IRE), unplaced, finished lame on its right fore.

#### **Race 8 - 8:00pm.**

##### **THE SKY SPORTS RACING SKY 415 HANDICAP STAKES (CLASS 6)**

Permission was given for SAMATIAN (IRE) to wear a red hood in the Parade Ring and go early to post.

The sponsorship in relation to BLACK SMOKE (IRE), trained by Mark Loughnane, did not comply with the Sponsorship Code of Conduct. Loughnane was warned as to his responsibility to ensure that the correct sponsorship is carried.

Approximately 2 furlongs out, TWOFORTHEGUTTER (IRE), placed third, lugged slightly left-handed before being corrected by its rider, momentarily leaving BURLINGTON HOUSE (FR), unplaced, short for room, but after viewing a recording of the incident, it was found that no riding offence was involved.

#### **Race 9 - 8:30pm.**

##### **THE AT THE RACES APP EXPERT TIPS HANDICAP STAKES (CLASS 6)**

Permission was given for BASHOLO (IRE) to wear a red hood to post; for SPANISH ANGEL (IRE) to go early to post; for NOTRE MAISON to go early to post wearing a red hood.

An enquiry was held to consider interference inside the final furlong involving, BASHOLO (IRE), placed third, ridden by Alex Jary, UNDER CURFEW, unplaced, ridden by Jack Doughty, NOTRE MAISON, placed fourth, ridden by Rob Hornby and PHOENIX BEACH (IRE), placed second, ridden by Dale Swift. The interference was found to be accidental as NOTRE MAISON had initially received some slight intimidation from PHOENIX BEACH (IRE) to its outside after that runner had edged left-handed, before being corrected by Swift. Thereafter, NOTRE MAISON had independently hung left-handed away from PHOENIX BEACH (IRE) despite Hornby switching his whip through and resulted in BASHOLO (IRE) being carried left onto UNDER CURFEW, which was badly hampered when checked against the rail.

Following the race, Alex Jary reported that BASHOLO (IRE), placed third, suffered interference inside the final furlong; Jack Doughty reported that UNDER CURFEW, unplaced, suffered interference inside the final furlong; Hollie Doyle reported that LADY BOUQUET, unplaced, hung right-handed throughout.
