Race 1 - 1:35pm .

THE JOHN DUNCAN BRACK APPRENTICE HANDICAP STAKES (CLASS 6)

Permission was given for BEARWITH to go early wearing a red hood to the start; for MAPLE to wear a red hood to the start.

Following the race, Matthew Lloyd Slater reported that BROADSTONE, unplaced, was slowly away.

Race 2 - 2:05pm .

THE www.eatflixcinema.com HANDICAP STAKES (CLASS 4) (GBBPLUS RACE)

Permission was given for RUBY WEDDING to wear a red hood to the start.

Following the race, the Veterinary Officer reported that TRIPOLI FLYER (IRE), which was pulled up, was lame on its right-fore leg. The Veterinary Officer reported that LAVENDER GOLD (FR), unplaced,

had bled from the nose.

Race 3 - 2:39pm .

THE SAY WHEN GOSFORTH AND PONTELAND EBF RESTRICTED NOVICE STAKES (CLASS 4) (for horses in Bands B, C and D) (EBF Restricted Race Qualifier) (GBB RACE)

Permission was given for MIRZIMAAN (IRE), MOLLISHA (IRE) and STAR MARTINI (IRE) to all wear a red hood to the start; for ON GOLDEN POND (IRE) to go early to post.

An enquiry was held to consider interference approaching the line involving the winner, ASANDER, ridden by Billy Garritty; ON GOLDEN POND (IRE), placed fourth, ridden by David Nolan and MOLLISHA (IRE), placed third, ridden by Ben Robinson. Garritty was suspended for 2 days for careless riding as he allowed his mount to drift right-handed without timely correction, moving MOLLISHA (IRE) off its intended line onto ON GOLDEN POND (IRE), resulting in both Robinson and Nolan having to take a check when short of room.

Approaching 2 furlongs out SUENICORA STAR, unplaced, lugged quick right-handed carrying MIRZIMAAN (IRE), placed third, off its intended line causing MIND THOSE STEPS, unplaced, to be crowded for room and checked. After viewing a recording of the incident, it was found that no riding offence was involved.

Inside the final furlong CHAN NOIR, unplaced, lugged left-handed at the same time as ON GOLDEN POND (IRE), placed fourth drifted right-handed causing ONE SHOT KODI (IRE), unplaced, to be short of room and checked. After viewing a recording of the incident, it was found that no riding offence was involved and had not improved the placing of ON GOLDEN POND (IRE).

Race 4 - 3:15pm .

THE BRACK BURGER ON UBER EATS BEESWING HANDICAP STAKES (CLASS 4) (DIV I)

Permission was given for both SOVEREIGN VIEW and VIPER to wear a red hood to the start.

Following the race, Ben Robinson reported that VIPER, unplaced, ran flat. The Veterinary Officer reported that PANDEMONIUM (IRE), unplaced, finished lame on its left-hind leg.

Race 5 - 4:00pm .

THE BRACK BURGER ON UBER EATS BEESWING HANDICAP STAKES (CLASS 4) (DIV II)

Permission was given for both FREDDIE STEADY GO and PENNY TIME (IRE) to wear a red hood to the start; for MR MISTOFFELEES (IRE) to go early to post.

The Starter reported that FREDDIE STEADY GO was unruly in stalls and was withdrawn at 4.01pm. Susan Corbett was informed that the gelding could not run until the day after passing a stalls test.

Following the race, the Veterinary Officer reported that PENNY TIME (IRE), which was pulled up, was lame on its right-hind leg.

Race 6 - 4:35pm .

THE JOHN AND ROSS GREENHILL HANDICAP STAKES (CLASS 6)

Permission was given for ADELAIDE BAY, ARRANMORE, MINERS GAMBLE (IRE) and PEBBLE DASH (IRE) to all wear a red hood to the start.

Inside the final $\frac{1}{2}$ a furlong as the rider of PEBBLE DASH (IRE), placed third, gathered his reins, the gelding lugged quickly left-handed carrying MERCURIUS POWER (IRE), placed second, off its intended line, who in turn moved ADELAIDE BAY, placed fourth, off its intended line causing MINERS GAMBLE (IRE), placed fifth, to be shifted off its intended line and becoming short of room, this resulted in BOOK OF LIFE, unplaced, being moved onto the heels of the winner, DEFENCE MISSILE (IRE). After viewing a recording of the incident, it was found that no riding offence was involved and that it had not improved the placing of PEBBLE DASH (IRE).

Race 7 - 5:10pm .

THE JIMMY TINDALL HANDICAP STAKES (CLASS 6)

Permission was given for SALLY ANNE'S DREAM to go early wearing a red hood to the start; for AURADUE to wear a red hood to the start.

The performance of SPARKLING WINE which finished last of ten runners beaten by $16\frac{3}{4}$ lengths, was considered. It was noted that the representative of Michael Dods could offer no explanation for the filly's performance.

Race 8 - 5:45pm .

THE AFTER PARTY AT TUP TUP PALACE CLASSIFIED STAKES (CLASS 6)

Permission was given for BELLING THE CAT to go early wearing a red hood to the start; for TIMEBAR to go early to post.

The performance of SASSY GLORY (IRE) which started favourite and finished twelfth of thirteen runners beaten by $20\frac{1}{2}$ lengths, was considered. The explanation given by the representative of Mark Walford that the mare ran flat, was noted. The Veterinary Officer examined SASSY GLORY (IRE) post-race and had nothing to report.
